2024 Accounting Engagement Letter

We appreciate the opportunity to work with you and advise you on income tax matters. The government agencies impose penalties on taxpayers, and upon us as tax return preparers, for failure to observe due care in reporting on income tax returns. In order to ensure an understanding of our mutual responsibilities, we ask all clients for whom we prepare tax returns to confirm the following arrangements.

We will prepare your 2023 personal income tax returns based on the information that you provide to us. We will not audit or otherwise verify the data you submit, although we may ask you for clarification of some of the information.

It is our responsibility to prepare your tax returns correctly according to the law and the information you have provided. It is your responsibility to provide us with all the information required to prepare complete and accurate returns. You should retain all the documents, canceled cheques, and other data that form the basis of your income deductions. These may be necessary to prove the accuracy and completeness of the returns to CRA. You have the final responsibility for the income tax return and, therefore, you should review it carefully before signing.

By signing this letter, you represent that you will provide us with the accurate and complete information necessary to prepare your tax return(s). This includes informing us of all interest you held in foreign properties with an aggregate cost in excess of \$100,000 at any time of the year, as well as all income from any foreign properties regardless of their aggregate value and all income and transactions relating to non-resident trusts.

The law imposes various penalties when taxpayers understate their tax liability. If you would like information on the amount or circumstances of these penalties, please contact us.

CRA may select your return for a review and request copies of your receipts up to and including a full audit. Any adjustments proposed by CRA are subject to certain rights of appeal. In the event of such tax examinations, we will be available upon request to provide representation on your behalf.

Our fee for services is based on our fee schedule plus out-of-pocket expenses. All invoices are due and payable upon presentation.
