Rental Rules

- **NO SMOKING!** This rule is strictly enforced and has a **Complete LOSS of Deposit** to anyone who violates it
- **NO PETS!** This rule is strictly enforced and has a **Complete LOSS of Deposit** to anyone who violates it
- **NO BICYCLES** carried on or in the RV
- **NO DRINKING** alcoholic beverages in the unit and a **Complete LOSS of Deposit** to anyone who violates this rule
- **NO STORAGE** on top of unit
- **NO CLIMBING** on the ladder or standing on top of unit
- **NO TOWING** is allowed behind any of the units
- **NO AWNING USE** unless you have rented it from I-80 RV SALES and RENTAL. Awnings can be rented for a \$75 fee
- I understand that I or anyone else that I may authorize to rent, pull, and/or use this RV must be **at least 25 years old**. Any misrepresentation of this or allowing anyone under 25 to tow this RV will automatically void any insurance coverage offered to the renter, the renter will be fully responsible for the value of the RV.
- Any towing of trailers outside of the United States is prohibited.
- All vehicles towing travel trailers **must** have a working electric brake system.
- Rentals can be picked up and returned between the hours of 8:00 AM and 4:00 PM Monday thru Friday. All rentals picked up and returned on Saturday or Sunday will be charged an extra \$25 fee. Any rentals returned after 4:00 PM will be charged the following late fees:

- In the event that the RV becomes un-rentable, not due to the routine mechanical failure, I understand that I will be responsible for all "loss of use" charges.
- Propane tanks are released full and must be returned full. If not, the renter will be charged \$50 fee.
- A fee of \$100 will be charged if the unit is not returned in a clean and appropriate manner as when it was rented.
- A dumping fee of \$75 will be charged if the holding tanks are not empty upon return.
- Pick up and delivery of units is available for an additional \$100 to approved camp locations.
- I-80 RV SALES and RENTAL must be notified immediately by phone or voicemail if any breakdowns occur. Authorization must be verbally approved by I-80 RV SALES and RENTAL prior to any repairs.
- I-80 RV SALES and RENTAL must be notified immediately by phone or voicemail if the rental is involved in an accident. A police accident report must be submitted to I-80 RV SALES and RENTAL upon return. Failure to comply will result in the forfeiture of your security deposit.
- Employment credit references and a valid driver's license must be presented when reserving a vehicle. **ALL INFORMATION WILL BE VERIFIED AND THE RENTER MUST PRESENT A PHOTOCOPY OF THEIR DRIVERS LICENSE AND INSURANCE CARD BEFORE TRAILER WILL BE RELEASED.**

Any violation of the above rules will result in the forfeiture of the security deposit.
