- 8. Beaver Brook is now a deed issue. Jim used lots of his money to keep it going. Closed.

RE: Upland Game Bird Stocking Program at Cape Cod National Seashore

Dear Superintendent Flynn,

The Massachusetts Division of Fisheries and Wildlife (MassWildlife) has a long history of working cooperatively with the National Parks Service (NPS) on wildlife conservation and associated passive outdoor-recreation opportunities at the Cape Cod National Seashore (CACO). As you are aware, MassWildlife has a pheasant and quail stocking program to provide additional upland gamebird hunting opportunities to the public. This opportunity is especially important in regions of the Commonwealth where the ability to pursue and harvest wild upland game birds is severely limited due to the disappearance of early-successional habitat from changes in land use (e.g., farm abandonment), limited habitat management, and/or the loss of open space due to development. Hunters that reside on the lower Cape have very limited opportunity to pursue upland game birds absent a public stocking program, therefore maintaining this opportunity at CACO is of paramount importance.

To provide some additional background and context, MassWildlife has been stocking the area where CACO now exists since the early 1900s. In 1961, roughly 500 acres of state-owned land on the lower Cape, including several areas where pheasant were stocked, became a part of CACO via a land transfer for \$1.00 to the federal government. The importance of hunting as a traditional activity at CACO was emphasized in the transfer's enabling legislation and within the "Foundation Document, Cape Cod National Seashore, Massachusetts." Unfortunately, in 2003, the pheasant stocking program at CACO was enjoined and the NPS was required to complete an Environmental Assessment to demonstrate compliance with the National Environmental Policy Act. Ultimately, the NPS completed an Environmental Impact Statement, and a record of decision was published in 2007 requiring a 14-17-year phase-out of pheasant stocking at CACO, resulting in the final year of pheasant stocking being completed during the Fall 2023 hunting season.

MassWildlife is requesting approval to transition to stocking of Northern Bobwhite (quail) in the same areas where we have stocked pheasants for over 120 years. Northern Bobwhites are native to Massachusetts, and this alternative stocking would provide the upland gamebird-hunting opportunity lost with the phasing out of the pheasant program. Further, it would maintain the long-standing and important heritage and tradition of hunters, sporting dogs, and upland bird hunting on Cape Cod. Such a stocking program is also in direct alignment with the NPS's mission to "[preserve] unimpaired the natural and cultural resources [emphasis added] and values of the national park system for the enjoyment, education, and inspiration of this and future generations."

MassWildlife is hopeful that the NPS will work collaboratively with our agency to ensure that this important opportunity and longstanding sporting tradition from the turn of the last century continues.
