If required, the Participant will obtain a medical examination and clearance.

### **Full and Final Settlement**

The Participant understands that by signing this Agreement, the Participant agrees to be forever prevented from suing or otherwise claiming against the Activity Provider for any property loss or personal injury that the Participant may sustain while participating in or preparing for the above noted activity.
- 8. The Participant has been given the opportunity and has been encouraged to seek independent legal advice prior to signing this Agreement.
- 9. This Agreement contains the entire agreement between the parties to this Agreement and the terms of this Agreement are contractual and not a mere recital.

#### **Governing Law**

10. This Agreement will be construed in accordance with and governed by the laws of the Province of British Columbia.
