Urgent Needs—If your city or county has an urgent need, contact our office before construction begins. There are no deadlines on urgent need. Examples of urgent need projects funded in our region:

- Edgeley Water Storage Tank - Edgeley's Storage Tank had serious structural issues that threatened their potable water to the city. Urgent need funding paid to build a new storage tank.
- Kulm - Severe winter weather took out their power and their water tower was drained, once power was restored, they were unable to pump water into the tower and had to replace their water pump. Urgent need funding paid for that pump.
- City of Kathryn - Sewer lines were not where they were stated to be on a city map and because of this, while installing rural water lines, crews bore through the sewer lines. Urgent need funding repaired the sewer lines.
- Barnes County Bridge Repair - A vital bridge in Barnes County was given a level 3 alert and was close to being shut down. Urgent need funding paid for the repair of the bridge to bring it up to code.
