



## NVKBA Rules Overview and Waivers

*Updated 2/17/2023*

Every NVKBA Competitive Event shares the same KBF Rules foundation, the KBF Competition Rules Standards. KBF's Rules Standards and Addenda comprise the complete set of KBF Rules imposed for each NVKBA competitive event.

NVKBA reserves the right to make alterations to KBF rules on a case-by-case basis which will be announced prior to each event via email and/or the captain's meetings. Any changes to rules will also be clearly annotated in the event description on the event page in Fishing Chaos so that any and all confusion is avoided. It is the **angler's responsibility** to ensure all rules and event descriptions are **read and understood** prior to registration. If no rule changes are noted, assume normal KBF rules will be followed for that event.

As conditions for participation in NVKBA events, each Competitor is required to become familiar with all the applicable rules and voluntarily agrees to abide by them and agrees with the attached waivers and release of liability agreements.

KBF Management and NVKBA Leadership make every effort to ensure the rules are complete, concise, and comprehensible. Our aims are to ensure that competitors understand KBF's rules, expectations, and/or guidelines and that directors and judges will administer them objectively and **IMPARTIALLY**.

Major KBF Rules are revised or supplemented from time to time for clarification or to cover issues not previously addressed. When significant changes are made, notifications are communicated on the KBF Facebook page, the KBF YouTube channel, email outlets, KBF Facebook page, and in the Kayak Bass Fishing and KBF Members Only forms.

I acknowledge that kayak fishing participation and competition involves certain inherent dangers, and hazards; that the risk of injury from the activities involved in this event is significant, including the potential for permanent paralysis and death, and while particular skills, physical fitness, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary Terms and Conditions for Participation (rules). If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and immediately bring such to the attention of NVKBA Staff, Officers, Tournament Directors, or contracted tournament management services.
5.
