



## 2026 NVKBA Rules Overview and Waivers

All Northern Virginia Kayak Bass Anglers (NVKBA), Inc. competitive events are governed by the NVKBA Competition Rules, which is built upon the same Kayak Bass Fishing (KBF) rules foundation as the traditional KBF Competition Rules. The most current version of the NVKBA Competition Rules Standard will be published on the official club website and clearly marked with its latest revision date.

NVKBA reserves the right to make alterations to rules on a case-by-case basis which will be announced prior to each event via email, captain's meetings, and/or the event details found on the Fishing Chaos event page. **It is the sole responsibility of the Competitor to ensure all rules and event descriptions are read and understood prior to registration.** If no rule changes are noted, assume the standard NVKBA rules will be followed for that event.

**As conditions for participation in NVKBA events, each Competitor declares during event signup that they have read and understood the NVKBA Competition Rules Standard, voluntarily agrees to abide by them, and agrees with the attached waivers and release of liability agreements (attachments A and B) based on their status (adult or youth). All youth anglers ages 17 and under are required to have a completed liability waiver on file prior to participation. The waiver must be digitally signed (or printed, signed, and scanned) by a parent or legal guardian who will accompany the minor on the water during the event.**

NVKBA leadership makes every effort to ensure the rules are complete, concise, and comprehensible. Our aims are to ensure that competitors understand NVKBA's rules, expectations, and guidelines and that directors and judges will administer them objectively and **IMPARTIALLY**.

Major KBF and NVKBA rules are revised or supplemented from time to time for clarification or to cover issues not previously addressed. When significant changes are made, notifications are communicated on the NVKBA email distribution via Fishing Chaos, NVKBA Facebook group and page, the NVKBA YouTube channel, and the NVKBA website.

**NORTHERN VIRGINIA KAYAK BASS ANGLERS WAIVER AND RELEASE OF LIABILITY AGREEMENT**  
*READ BEFORE REGISTERING FOR ANY NVKBA COMPETITIVE EVENT AND/OR SIGNING THIS AGREEMENT*

In consideration of being allowed to participate in any way in the NVKBA, Inc.'s Event and its related competition and activities, I, the undersigned (or Registrant), being under the age of 18, acknowledge, appreciate, and agree that:

1. I affirm that Registrant's participation in any NVKBA Event is voluntary and declare that Registrant is physically fit and capable to participate in such; and
2. I acknowledge that kayak fishing participation and competition involves certain inherent dangers, and hazards; that the risk of injury from the activities involved in this event is significant, including the potential for permanent paralysis and death, and while particular skills, physical fitness, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
3. Registrant (and Adult Parent, Guardian, or Designated Adult Supervisor) KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for Registrant's participation; and,
4. Registrant willingly agrees to comply with the stated and customary Terms and Conditions for Participation (rules). If, however, Registrant or Adult Supervisor observes any unusual significant hazard during their presence or participation, they will remove themselves from participation and immediately bring such to the attention of NVKBA Staff, Officers, Event Directors, or contracted digital management services.
5. in full recognition and appreciation of the dangers and risks inherent in such activities, I (and Adult Parent, Guardian, or Designated Adult Supervisor), for myself and on behalf of my heirs, executors, administrators and assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS NVKBA, Inc. and its owners, officers, managers, officials, volunteer event staff, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, event service/management and technology providers (including but not limited to Fishing Chaos and/or TourneyX), and, if applicable, owners and lessors of premises used for the activity ("Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law, and I hereby waive, release, and forever discharge Releasees from and against any and all claims, demands, actions, or causes of action, for costs, loss, expenses, or damages to personal property, or personal injury, or death, which may result from Registrant's participation in the NVKBA Event.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
