<u>CLUB INTRODUCTIONS</u>. Introductions by club presidents and other club officials were presented.

#### **GOTSPORT-**

**STYSA Summer GBM**. Thomas Morrow recapped the Summer GBM held last weekend at the Sugarland Marriot. He explained the various sessions/workshops and encouraged people to attend a state meeting in the Texas. Next meeting will be in El Paso.

FIFA has a deal with STYSA to bring more Coaching education to the area.

**SAFE SPORT**. The law requires mandatory reporting if facts give reason to suspect someone within 24 hours.

Make sure all board members listed on your website are up to date with their safe sport and background.

Now players turning 18 or already 18 will be required to complete Safe sport.

Question was also posed about suspension of adults with pending investigations. US Soccer recommends using terminology 'interim disqualification' when there is concern regarding safety. US Soccer is also looking to develop baselines to more uniformly handle hits on background checks.

Protocol for BAYSA. If a club representative believes the incident is of such to warrant more action, inform Thomas Morrow, and he and Dave Smith, BAYSA D&P, will determine if "interim disqualification" is needed.

#### Registration-

All D4 players must be registered.

Invoices- end of the year sweep for summer player

Try to get teams in by August 1st, August 10th is a grace

August 10<sup>th</sup> will be when D2, D3 rosters need to approved. Virtual cards can be used but cards still need to be printed. Rosters size changed for 13u and up to 22 max rosters. With the new systems all pictures must be updated. Photos will need to be updated every 2 years.

**FINANCIALS**. Rich Newell presented information on financials. There are increases for the 2020/21 seasonal year for player and team fees below.

- Teams fees and player fees for the minimum rosters need to be in Gotsport by Aug 21<sup>st</sup>. On Aug 23<sup>rd</sup> Melyssa Bratton will send spreadsheet with team fees and player fees from Roster.
- Recommended that the treasurer and one other board member monitor transactions.
- Clubs should have budget.
- Clubs should file 990's annually.
- Went over North Channel and how they are going to get their club caught up. North Channels needs to show a plan of how they are going to play.
- North Channel can't take any allocation spot if they are not at a zero balance.
- They should be only have \$1000 balance

GOAL POST AND CERTIFICATE OF INSURANCE APPLICATIONS. Goal post inspections and certificates of insurance applications are due at today's meeting. If these forms are not received by August 15, club's Got Soccer access will be terminated and club fall schedules will be withheld. Please send to Shirley McGraw at shirleysoccer@gmail.com.

**REGISTRAR.** Shirley McGraw presented information on registration. Shirley McGraw's email is <a href="mailto:shirleysoccer@gmail.com">shirleysoccer@gmail.com</a>. Registrars meeting will be August 5<sup>th</sup> at 6:30.

- Invoices. Player counts will be sent to clubs on a monthly basis. Invoicing for players will return to the October 1, November 1, April 15, and July 31 deadlines. Clubs should/must reconcile player counts on a monthly basis and pay invoices on time. All players, including in-house recreational players must be registered in Got Soccer and team rosters generated. For the younger age players, large team pools may be formed (increase team roster limit). Contact Shirley McGraw to get roster limits disabled to accommodate this quick roster for younger players.
- Adult Registration. In addition to the required background check every two years, STYSA requires completion of the CDC module on concussion management and training on the Safe Sport module that covers mandatory reporting, sexual misconduct awareness education, and emotional and physical misconduct. Coaches may not be registered to teams without completion of these requirements. All users in the club's Got Soccer account must be approved (background check, etc.) completed by September 1 or account will be disable.
- Each team must have one coach rostered to the team in order to generate a team. Player information must be marked verified by the registrar before player can be rostered to a team. GotSoccer will manage registrations daily and lock all verified players.

**SCHEDULER**. Sayed Naser discussed scheduling and the fall season 2022 (dates on next page). No reschedules except for rainouts. Please do not give his personal email to coaches and parents; send scheduler email requests to <a href="Melyssabaysc@gmail.com">Melyssabaysc@gmail.com</a>. BAYSA plans to schedule as many games as possible on Saturdays then use Sundays for overflow especially if we have rainouts. We should will begin games at 8:00 a.m. on Saturdays and Sundays.

**RISK MANAGEMENT.** Thomas Morrow made a presentation on risk management during lunch. He highlighted risks associated with goal posts, background checks, safe sport, etc.

**D&P**. Dave Smith made a presentation on BAYSA D&P. Some of the highlights of his presentation are:

### How to protest a game:

- If a coach believes that a "rule of the game" has been broken, for example: overage player, not playing all players 50% of the time, a Ref not using the correct rules of the game in an age bracket, then a protest maybe filed.
- A coach needs to inform the center referee before the end of game that he/she is going to file a protest. The referee (not the coach) writes "Protest" on the card at the end of the game when the card is signed by both coaches. The opposing coach must be notified of the protest, that's the coach responsibility, not the ref.
- Immediately following game completion (within 48 hours), the coach should file a written report explaining why they are protesting the game and send it to their club D&P representative.
- The club (not the coach) will send notifications to the BAYSA D&P Chairman.
- BAYSA does not charge protest fees, however, should a protest be moved to a higher authority, there are protest fees at the state, regional and national levels.
- Protesting is not designed to deal with bad referee calls, there is a different process for such.

### Don't like the Way the Referee Called the Game

- Examples; referee did not keep up with the speed of play, safety of players is not properly prioritized, or interacting with sidelines. If so, coach should ask that a referee evaluated.
- A Coach may send a request to BAYSA for a referee to be evaluated. That request will be processed through the D&P committee and forwarded to the Referee Assignor.
- Be mindful that "disagreeing with a call" is different than a referee not being capable of handling the game. D&P will not over rule a referee for a judgement call.
- Referee abuse will not be tolerated, on or off the field.

<u>Player Cards</u>. Regardless of the league's player card policy, coaches need to have the physical player cards at all games at all times. Player cards should be current year, laminated and have a photo affixed.

<u>Game Cards</u>. Both coaches are responsible for bring a game card to the game. It is best to print out the game card the day before the game, to make sure it is up to date and current. If a coach's signature is illegible, they should also print their name below their signature, we need to be able to identify the coach by their signature.

Lop-sided Games/Unsportsmanlike conduct. Encourage coaches whose teams are not being challenged during games, to move up in competition (from recreational to competitive). A coach should recognize in first five minutes if a game is going to be lop-sided. There is a 10 goal rule in BAYSA, if a coach allows the score to run up to 10 or more goals, the coach will be sanctioned, first with a warning then with a suspension. Warnings carry over from one season to the next.

#### <u>REFEREES</u>

All issues with parents need to go through the coach.

Next Classes- Aug 4<sup>th</sup>, Aug 6, and Aug 11<sup>th</sup>. Follow up on referees that you have brought in are communicated with.

On Saturday Donald will pick up, if he is not available Lindsay Hood or Melyssa Bratton will pick up. On Sunday if no one is there is pick up they are to be put in the scorekeeper mailbox.

#### COACH'S MEETING

Aug 26<sup>th</sup> both in person and virtual will go over many rules. If any club would like to host a coach's meeting in there club Melyssa will go and do a private meeting for those clubs.

<u>D2L Fees and Policy</u>. There are new policies for registering D2L. Every team playing in the Eastern District D2 League (D2L) is required to pay their 2019-2020 D2L fees to their local CLUB/ASSOCIATION according to the CLUB/association POLICIES. Your club or association registrar will enter your team in the GOT Soccer D2L league event. D2L League Event in Got Soccer: search Division 2 League

2019-20 D2L Fees. Fees cover all administration, field rental, referee fee, and other league costs. Neither Association fees, club fees nor STYSA Fall Championship fees are included.

11U-14U Teams: \$105 game, \$1,575 based on 15 game Fall and Spring season

11U-14U teams may pay in two installments: Fall 2019 \$1,050 and Spring 2020 \$ 525

\**U11 Qualifying Event, if any, is a separate fee* 15U-19U Teams: \$130 game, \$1,300 based on 10 game Fall season

Accepted Forms of Payments. Teams will remit their team payments in accordance with their local club and association guidelines. The Associations will be billed for League Fees by the Eastern District D2 League.

Payment Deadline: Associations are required to pay all D2L fees by Friday, August 30, 2019. If a team pays for more games than are ultimately scheduled, the association will get a refund for the difference. Refunds for the 11U-14U 2018-2019 season are being processed by the D2L Treasurer. Refunds for 15U and older teams were processed.

Failure to Pay. If fees are not paid in full by September 6, 2019, the team will forfeit their 1<sup>st</sup> D2L game (the game will NOT be played), but will remain in the league on probation. If the team is not paid in full (for the 2019- 2020 season) by September 13, 2019, the team will forfeit their 2<sup>nd</sup> D2L game (the game will NOT be played) and will be removed from D2L according to league rules (failure to play two scheduled games).

If there are extenuating circumstances regarding league payment, the D2L administrator must be immediately contacted. Gina Klein, edd2league@gmail.com
