### Waiver, Indemnification and Assumption of Risk Agreement

The Property is rural land which has a pond and other features normally found in pastureland. Animals may create hazards on the property that could cause personal injury or cause property damage. Now, THEREFORE, in consideration of being allowed to participate in said activities, the person(s) applying below dooø by submission of this form release and forever indemnify, discharge, and hold harmless the Club, its officers, directors, members, participants, spectators, all land owners and lessees of the land that the Club may be using from any and all manner of actions, claims, and demands whatsoever, in law or in equity, which may arise now or in the future because of, or pertaining to, the person(s) applying below participation in any of its activities. The person(s) applying below further agree to pay for any injury or damage that their dog may do to other animals or persons or property while participating in Club activities on property in use by the Club.
