Sir / Madam,

The Animal Welfare Board of India (AWBI) is a statutory body established under Section 4 of the Prevention of Cruelty to Animals Act, 1960. The functions of the Board include the promotion of animal welfare generally for the purpose of protecting animals from being subjected to unnecessary pain or suffering, in particular.

The Central Government has notified Prevention of Cruelty to Animals (Marketing and Care of Case Property) Rules 2017 for the maintenance of Animals seized in violation of Act and Rules made thereunder (copy attached).

It is noticed that the above Rules are not implemented in letter and spirit and resort to avoidable burden on Animal Welfare Organizations and Governmental agencies

We draw your kind attention towards provisions of Section 4 of cost of care and

State Board shall within in 3 months from the date of commencement of these rules and thereafter on the 1st day of April every year, specify the cost of transport, maintenance and treatment per day for every species of angular than its comments served in the State.

You are requested to inform the action taken if any, and the rates fixed. If no rates are fixed, then you are requested to fix the same at the earliest with intimation to the Board.

Till the rates are fixed, we advise you to circulate the following rates (for the care and Maintenance of animals pending litigation) to all concerned subordinate offices:-
