Robberies and auto theft have been common along Benning Road and Minnesota Avenue. MPD encourages residents to be mindful of what they leave in their vehicles, and to use Amazon lockers and other safe package spaces.

b. Montage Development Group - Kevin Brown

Rosewood Strategies LLC & Montage Development Group are integrated real estate development firms focused on strategic high-impact development opportunities in the Washington DC metro area. They are working together to make map amendments on the

property at 3747-3759 Minnesota Ave NE in 7F02. The project will be completed in square 5048 W on lots 825,826, and 828. There are currently four four-unit buildings on the property. Under the map amendment, the firms will be able to build buildings that are approximately six stories with 75-90 units. The firm has helped renovate buildings for organizations such as Martha's Table, Community of Hope, and the WACIF Headquarters. Regarding parking, the firm is in the early stages of the project but plans to provide parking on-site that can be accessed from the alley. Additionally, current tenants will be given the opportunity to relocate to one of the current buildings, and seniors will be given the opportunity to return to the new buildings upon completion.
