General Commission Meeting Minutes December 15, 2020 Time: 6:30 p.m. via Zoom due to COVID-19

Call to Order

• Chairperson Holcomb called the meeting to order at 6:42pm.

Commissioner Roll Call

• Commissioners present: Commissioner Holcomb, Commissioner Hunter, Commissioner Fletcher, Commissioner Hughes. Quorum was established.

Adoption of the Agenda

• Chairman Holcomb moved to add "Approve payment for EHT Traceries, Inc." to the agenda, seconded by Commissioner Fletcher. The Agenda was adopted unanimously with the proper amendments with Commissioners Carson-Carr and Exum absent.

<u>Updates</u>

• MPD - Captain Conners

- Year to date there is a 2% increase in crime. Property and motor vehicle theft are up 50%, violent crimes are down 1%, assault with weapons are down 16% and homicides and gun crimes have increased.
- o There has been a gun recovery on the 3900 block of Minnesota Avenue.
- o A case closed for an attempted bank robbery in a matter of two minutes.
- o Uber/Lyft and delivery drivers are being targeted for carjacking. MPD suggests being aware of your surroundings when parking and leaving your car.
- o More officers are being dispatched to patrol areas where crimes have spiked.

• Mayor's Office - Wesley Leary

- o Churches are being asked to reduce capacity from 100 people to 50 people.
- o Restaurants are being asked to close by midnight and stop the distribution of alcohol by 10:00pm, this excludes carryout and delivery.
- o Private trainers and other gym facilities are being asked to suspend all indoor group exercising. Outdoor groups are allowed with a maximum of 25 people.
- o The district will have 6,825 dosages of the COVID-19 vaccines, the initial dose will be provided to healthcare workers and frontline workers.
- o Within two dosages the vaccine has been proven to be 95% effective, possible side effects are similar to flu symptoms. For more information on the vaccine, residents can go to coronavirus.dc.gov
- o The mayor has allotted \$9 million for housing stabilization which allows people who are experiencing hardships with housing and rent to be provided relief

• Councilmember-Elect Christina Henderson

- Newly elected council member Christina Henderson wishes to make DC more sustainable and equitable for everyone, while not allowing residents to be displaced. This includes focusing on issues such as affordable housing, access to public transportation, homelessness and hunger, and maternal health for women in the city. Henderson has also made it clear that she finds it important for residents and MPD to have a certain level of trust

• Councilmember Vince Gray

- Councilmember Gray wishes to continue focusing on the healthcare deficit present in Ward
 7 and Ward 8.
- o \$383.7 million has been invested to create a new hospital in the East end to replace the Greater southeast Hospital.
- o In the upcoming year, there will be 2-3 new urgent care centers in Ward 7.
- o The architect for these new buildings is expected to be selected within the next 2-3 months. These establishments will serve over 162,000 people.
- o There is a new Department of General Services (DGS) office being built on Minnesota Avenue in the next 18-24 months. This construction will bring about 500-600 jobs to the city.

Community Concerns/Announcements

• Sean Flora & Dr. Natalie Smith, founders of Global City Public Charter School are offering language emergence classes in the top 3 spoken languages in the world. This public school allows children to access language opportunities in Ward 7 which prevents families from traveling far. This is the first public school to offer both Mandarin and Chinese language courses. Classes for Mandarin and Spanish begin in January and each class will host up to six children.
