Call to Order

• Commissioners present: Commissioner Holcomb, Commissioner Fletcher, Commissioner Hughes. As a quorum was not established, no Commission Business can occur. A special call meeting will occur next Monday, August 31st.

Halfway House Advocacy Update

• CORE DC has been awarded a contract by the Bureau of Prisons to operate a halfway house at 3701 Benning Rd NE in June of this year. We as a Commission have been working diligently to make sure that our voice has been heard on this issue. We have held two town halls with CORE DC, one with community leaders and one with the general community at large. We are not against returning citizens and understand the need for successful reintegration, but there are other issues in our community in that area that need to be addressed first. We do not have a quorum for this meeting, but at our next meeting we plan to officially nominate 3701 Benning Rd NE for the DC Inventory of Historic Sites and to set aside money from our Community Benefit Fund to do an impact study on this area. We hope that through these efforts our advocacy is clear and impactful. We have a plan that presents returning citizens in our community and the responsibility of their successful reintegration on the entire city of Washington, DC and not just on Ward 7 and an upcoming meeting on September 9th. We are continuing to put pressure on CORE DC, the Bureau of Prisons, and Congresswoman Norton. We have until September 5th provide feedback on the permit. We will institute a letter commenting on the lack of an impact study and putting in the Historic Site request.
