#### **Brief Overview of the Meeting Minutes**

The meeting was called to order at 6:39pm, with a moment of silence observed. Present were Commissioners Holcomb, Ruff, Nelson, Orrendoff, Hughes, Edwards, Thompson-Wright, and Hayes.

Community Updates & Announcements: Lieutenant Anderson provided a public safety update, highlighting a decrease in overall crime and the implementation of a business focus unit. Discussions included the summer crime initiative and the effectiveness of drug-free zones. Detailed statistics on drug-related calls were provided. Commissioners Thompson-Wright and Hayes brought up questions about the effectiveness and additional resources for drug free zones. As well as MPD's plan for Summer Crime Initiatives (SCI)

Presentations/Special Guests: Jose Lopez from DGS, accompanied by Taylor Jones and Anthony Harris from Quinn Evans, presented the Fort Dupont Ice Arena project. Highlights included:

- Overview of the project and its timeline.
- Current construction status and upcoming activities.
- Discussion on the new entrance, addressing community safety concerns.

## **Resolutions Passed:**

Resolution 24-006: Ceremonial naming of the 200 block of 37th Place SE Pearl's Way. Resolution 24-007: Opposition to DDOT's Notice of Intent for Left Turn Restrictions at Benning Service Road NE and Minnesota Ave NE.

Discussion: Commissioners discussed the CBA fund budget and the potential need for adjustments due to inflation, which was approved unanimously 7-0-1.

The meeting adjourned at 7:58pm.

## **Summary Highlights:**

- Public Safety: Significant decrease in overall crime.
- Drug-Free Zones: Reduction in drug-related calls, but more data needed.
- Summer Crime Initiative: Plans underway for community safety.
- Benning Stoddert Recreation Center: Concerns about resource improvements.
- Community Sponsorships: Emphasized for supporting local events.
- Budget Priorities Resolution: Focus on lighting, beautification, safer passage for students, and community grants.
- CBA Fund Budget: Possible adjustments due to inflation.
