Please start gathering the following documents. You will not need them for our initial consultation, but you will need them no matter whom you hire to represent you:

1. Tax returns: the last three filed – including all attachments: i.e., W-2, 1099, K-1's, and all schedules and worksheets.
2. Verification of current income – paystubs for the last 6 months.
3. Financial Accounts: checking, savings, investment accounts, etc. – the immediate prior 12 months of statements.
4. Retirement Account statements for immediate prior 12 months.
5. Deed (to any property owned or a party has ownership interest in)
6. Employer benefit plan along with the name and number of person to contact for information
7. Life Insurance Policies – policy's financial information and cash value
8. Titles (auto, boat and motorcycle) – listing of equipment on each
9. Expenses – total of past twelve months on each bill (utilities, phone water, etc.)
10. Liabilities/debts (both parties)- most current statement of each (credit cards, loans, medical) plus 2 years
11. Mortgage balances- total owed and monthly payments (please advise whether it includes taxes & insurance)
