- 1 The above hunter can take one buck and one doe, The buck must score 130 or more gross P & Y. Any buck scoring less than 130 will result in a \$ 1,000.00 fine to be paid prior to departing BCF lodge. A wounded deer is considered a harvested deer.
2. Hunter agrees to comply with all applicable State and Federal laws and regulations pertaining to the hunting and harvesting of deer on said premises and agrees that he will not engage in any unlawful activity while he or she is on said premises.
3. Hunter agrees that he or she alone is responsible for the safety of their being and others and that it is their own responsibility to insure their safety while on the premises and shall inspect and secure all stands adequately, and shall at all times wear a safety belt or harness while positioned on any stand. Hunter acknowledges that participating in hunting is a dangerous activity. The hunters, personal representatives, heirs, and next of kin, hereby releases, waive and discharges and covenants not to sue Buck Creek Farms, the landowners, their agents, lessees, employees, personal representative assigns, heirs and next of kin (hereinafter releases) for any and all loss or damage, and any claim or damage thereof, on account injury to the person or property or resulting in the death of a hunter, whether caused by the negligence of releases or otherwise while hunter is on the aforesaid premises or in any manner conducting activity pursuant to this license.
4. Hunter agrees not to bring alcohol or illegal substances on premises.
5. Hunter understands that Buck Creek Farms can not make any guarantees about game seen or harvested.
