CALL TO ORDER

The Southern Pines College and Career Academy (SPCCA) Board of Directors met Wednesday, January 5, 2022, at 11:00 a.m. Dr. Scarlett Copeland called the meeting to order and welcomed everyone. CHIEF EXECUTIVE OFFICER'S REPORT

New Board Members

Dr. Glenn Deibert, SPCCA CEO, had the opportunity to meet and provide an orientation to the two new SPCCA Board Members, Laura Bloom and Gary Evans. Dr. Deibert, traveled to Hazlehurst and met with Ms. Bloom November 30th and with Mr. Evans December 21st. Both will be great additions to the SPCCA Board of Directors.

Renovations at Coastal Pines Technical College (CPTC) Baxley Site

Renovations are officially underway at the CPTC Baxley Campus. Because the renovations have a significant impact on the offerings that will be available to College and Career Academy students, Dr. Deibert will continually give updates to the SPCCA Board members.

SPCCA Facility Design Progress

Dr. Deibert continues to work with Cogdell Mendrala Architects on specific details of the new building design. The preliminary submittal (the 60% progress on the design documents) was sent to the State Fire Marshall for a preliminary review. The State Fire Marshall's Office will review the completed design documents again prior to the bid.

SPCCA Interior Finishes

The SPCCA logo was established with two official colors as outlined below. The architect is at the point of the design process where specific finishes such as carpet, paint and tile need to be selected. The two SPCCA logo colors are similar to the CPTC colors, but they have a bolder brighter look whereas CPTC campus finishes have a neutral softer color. The recommendation is to use the SPCCA logo colors as a basic starting point in the selection of interior finishes. Additionally, these colors blend well with CPTC colors.

Updated Building Renderings

Tuesday, January 4, 2022, Dr. Deibert emailed updated renderings to the SPCCA Board members. For future reference, these will be attached to this month's Board meeting minutes.

SPCCA Construction Classroom and Lab Equipment

Dr. Deibert thanked Dr. Flowers for suggesting that a request for a recommended equipment list be submitted to the State. The architect requested and obtained a recommended equipment list for the Construction Lab from the Georgia Department of Education. Although it is not all inclusive, it does include approximately \$47,000 worth of items that need to be purchased for the classroom/lab once the new building is completed.

Dr. Deibert met with CPTC President, Mr. Lonnie Roberts, and asked Mr. Roberts to consider funding the equipment. Mr. Roberts approved the request, and the purchasing process has begun. The equipment will be stored by the College until completion of the SPCCA construction classroom/lab.

Electrical Lineworker Program

Dr. Deibert thanked the Board members who volunteered to serve on the Electrical Lineworker project. Two tasks are in process: (1) Dr. Deibert has contacted Mr. Jim Tucker at Satilla EMC and will establish a meeting this month with him and those working on this project who would like to attend and (2) Coastal Pines Technical College is gathering information for the group that will outline the curriculum, sample schedules, contact hours, equipment lists and other pertinent details. Board of Directors Training (February 2)

Mr. Pinson and Ms. Myers, the College and Career Academy trainers from TCSG, have reviewed and approved the draft training agenda. Three workforce development training contact hours will be issued to each board member who attends the training.

As a reminder, only voting Board members are required to attend the training. Dr. Deibert recommends all Board members who can attend the training should do so and the training hours for non-voting Board members be recorded as well.

OPEN DISCUSSION

Dr. Copeland thanked CPTC President Roberts for assisting with the equipment purchases for the construction lab and classroom. Assisting with the equipment purchases helps to keep the costs at a minimum for the College and Career Academy.

After viewing the rendering emailed to the Board by Dr. Deibert, Dr. Copeland recommended inserting the College and Career Academy name on the front of the new building. Dr. Deibert indicated the architect has already revised the renderings to show that change and the new version will be emailed to the Board later today. Ms. Thomaston suggested instead of sending the larger .jpg file, simply use the Snipping Tool and insert the picture into the body of the email. Dr. Deibert agreed that was a good idea and the updated rendering will be sent in this new format.
