CALL TO ORDER

The Southern Pines College and Career Academy (SPCCA) Board of Directors met Wednesday, May 3, 2023, at 1:32 p.m. Mr. Sidney Wildes called the meeting to order and welcomed everyone. A quorum of voting members was present.

APPROVAL OF AGENDA

CHAIRMAN'S WELCOME AND COMMENTS

Mr. Wildes welcomed the group and thanked everyone for attending the meeting.

HEALTHCARE WORKFORCE DEVELOPMENT NEEDS PRESENTATION

Ms. April Worth (Human Resources Director) and Ms. Jordan Jones (Registered Nurse), employees of the Appling Healthcare system, provided an information and training session on local workforce development needs. The newly formed partnership between the Appling Healthcare system, Southern Pines College and Career Academy and Coastal Pines Technical College will promote local job opportunities, educate students on salaries and benefits, and highlight continuing education opportunities for employees.

CHIEF EXECUTIVE OFFICER'S REPORT

Education Affiliate Board Member Term Limits

On March 14, 2023, Dr. Deibert emailed SPCCA's four school superintendents and college president (all voting education affiliate board members) to assess their interest in serving a second term which begins July 1, 2023. All five members confirmed they are willing to serve again (if voted to do so by the Board) and also confirmed the four non-voting members under their supervision can serve another term as well.

Upon a motion to approve by Mr. Kurt Davis, a second by Mr. James Futch, all nine current education affiliate Board members were unanimously approved to serve a second two-year term.

Election of Officers

During the June 7, 2023, Board of Directors' meeting, Board members will be tasked to elect new officers for FY2024. Nominations will be received and a vote on the new officers will take place during the meeting.

Job Descriptions and Job Postings

Dr. Deibert announced the two new positions for the SPCCA, Onsite Coordinator (full-time) and Secretary/Receptionist (part-time), should be posted during the month of May. Postings will be circulated by some of the local Chambers and on the partners' school systems web sites.

New Board Member Orientation

On March 7, 2023, Dr. Deibert met with Ms. Kelly Shanklin and conducted her new Board Member Orientation online via TEAMS.

Bills of Interest (SB 86 - Dual Enrollment Student Access to Hope Grant Funding)

Dr. Deibert provided a brief overview of SB86 which was recently signed into law by Governor Kemp. This information will be emailed to the SPCCA Board of Directors this week. A summary of the legislation is outlined below.

Senate Bill 86 allows high school students to access HOPE career grant funds irrespective of whether they have reached their 30 hours of Dual Enrollment funding. There is language to provide for program reporting from GSFC and TCSG to make sure this effort continues to

streamline industry driven programming available to high school students. The goal - get high school students into the workforce faster with a higher level of post-secondary credentials.

Construction Update

Since the groundbreaking back in November, the contractor experienced four major supply chain issues which include not being able to obtain:

- (1) an 800-amp electrical panel solution: redesigned the facility to use (4) 200-amp panels
- (2) a transformer from Georgia Power (52 week lead time) solution: after multiple letters and phone calls, Dabbs-Williams Contractors and Cogdell Mendrala Architects were able to convince Georgia Power to prioritize our project and a transformer is now on-site
- (3) a Gear (electrical purposes) solution: after much networking, the gear needed was secured
- (4) four HVAC Roof Top units solution: Cogdell Mendrala Architects is working with the sub-contractor and has successfully secured three of the four units and expects to secure the remaining unit within a week to ten days

Updated Construction Schedule

Based upon the information outlined in the construction update, the schedule for the completion of the new building should be around August 1.
