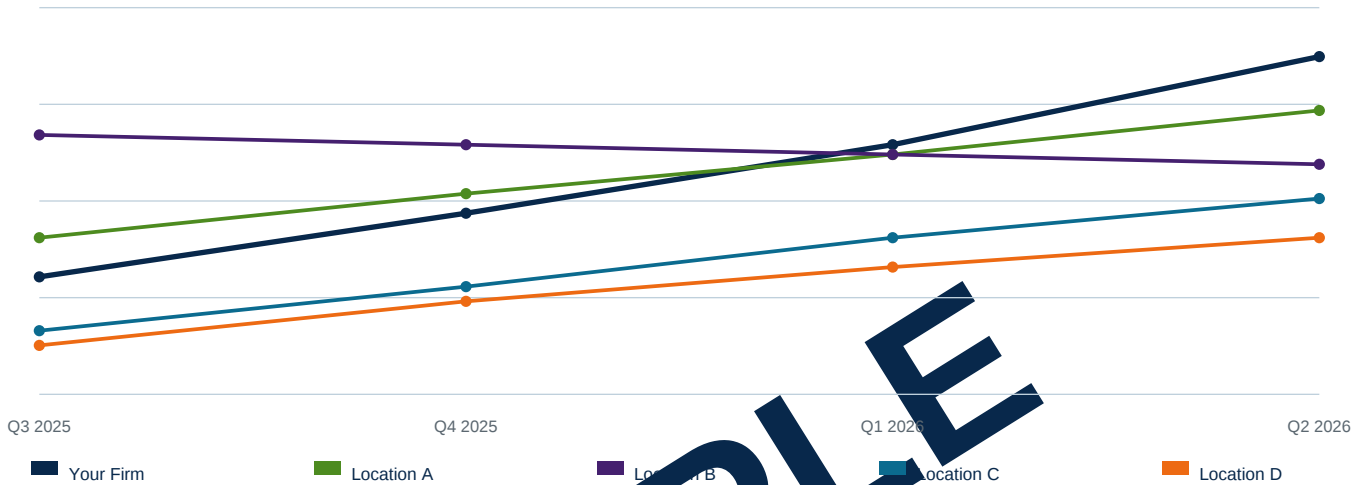
Comparison share measures each location against the selected group. State rank shows its position within the full establishment-level state source. The two measures answer different management questions.

12-MONTH INTERPRETATION

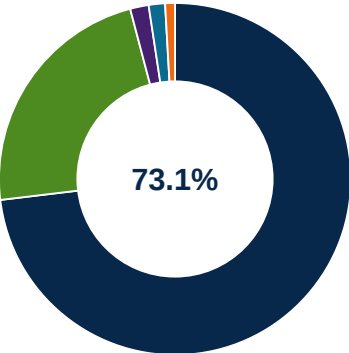
- Your Firm shows sustained growth across all four completed quarters.

The 12-month report combines four completed quarters into one executive comparison.

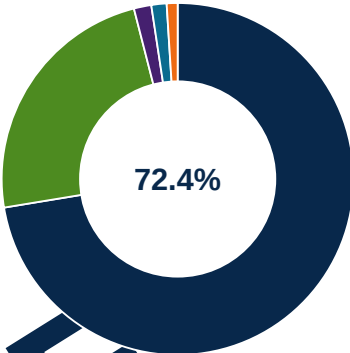
