Fall River Special Road District Meeting Minutes - Open to the public

Comments were made before the meeting started that the public is not invited to speak at SRD meetings.

- SRD meetings are working meetings and not hearings. Board meetings are the only times when the board has the opportunity to discuss the business of the Road District.
- According to the Attorney General's Public Records and Meetings Manual 2019/.Public Meetings/D4:
  - The Public Meetings Law is a public attendance law, not a public participation law. Under the Public Meetings Law governing body meetings are open to the public except as otherwise provided by law.
  - The right of public attendance guaranteed by the Public Meetings Law does not include the right to participate by public testimony or comment.
- Any person wishing to speak at an SRD meeting, or any person who has an issue they wish the board to consider, must contact the board:
  - In your message please state the topic you wish to address, or you want the board to address.
  - Agenda items proposed by non SRD board members will be reviewed for relevance prior to being placed on the agenda.
  - Time limits will apply
  - Please send your request well in advance of the meeting so that your items can be considered.
