Terms and Conditions for bourse space at the show are as follows:

1. This is an invitational show, and any application may be denied, Bourse tables are available to licensed dealers and collectors (Vendors) for the displaying, buying and selling of numismatic-related and other approved items.
2. ID badges must always be worn on the bourse area. Church-Hall is a non-smoking facility.
3. Vendors must secure their own insurance. Insurance is not provided by the West Hernando Coin Club or St. Joan of Arc Catholic Church against casualty, fire, theft, or loss of property by injury or otherwise, to any vendor, agent, or employee.
4. The sale of altered or counterfeit material is strictly forbidden by the West Hernando Coin Club. The Club reserves the right to prohibit the display or sale of an item not conforming to accepted standards of numismatic property. Copies and reproductions shall be labeled as such. No firearms shall be displayed for sale.
5. Bourse space may be sublet ONLY with the permission of the Bourse Chairman.
6. Bourse Chairman may assign a Vendor at his own discretion. Interference by any Vendor with the activities of another Vendor will not be tolerated. Any such occurrence should be reported to the Bourse Chairman. The Vendor committing the offense may be asked to leave the Show and may be prohibited from participating in any future West Hernando Coin Club events.
7. Dealers vacating their space(s) prior to 2 p.m. will risk loss of table(s) and/or preferred location at future shows. Bourse space must be vacated by 3:30 p.m. on day of Show.
8. Vendors are solely responsible for all sales tax in accordance with Florida State Law.
9. No signs over 18" high are allowed unless approved by the Bourse Chairman.
10. Only trained service animals recognized by ADA and Fla. Law are allowed during Show set-up, public hours and Show breakdown. Comfort and/or emotional support animals are NOT service animals are not recognized by the ADA.
11. The undersigned states and agrees that he/she is an authorized agent for the Vendor listed below and agrees to full compliance with the contract.
12. If security is needed beyond Show closing, contact Security upon arrival (at the Vendor's expense).

Uniformed Armed Sheriff will provide security.

The applicant agrees to comply with all of the rules set forth in this contract. Applicant hereby releases and forever discharges West Hernando Coin Club and St. Joan of Arc Catholic Church, including all officers and members of any and all manner causes of action, suits, proceedings, debts due to contracts, judgements, damages, claims or demands whatsoever in law or equity which may arise from loss whatsoever including loss, damage, or physical injury, however sustained, directly or indirectly in connection with the Show.
