- 2. ID badges must be worn at all times in the bourse area. Bourse room is non-smoking.
- 3. Vendors must secure their own insurance. Insurance is not provided by the West Hernando Coin Club or the St. Joan of Arc Catholic Church against casualty, fire, or any loss of property by injury or otherwise to any vendor, agent, or employee.
- 4. The sale of altered or counterfeit material is strictly forbidden by the West Hernando Coin Club. The Coin Club reserves the right to prohibit the display or sale of any item not conforming to accepted standards of numismatic property. Copies and reproductions shall be labeled as such. No firearms shall be displayed for sale.
- 5. Bourse space may be sublet only with the permission of the Bourse Chairman.
- 6. Bourse Chairman may locate a Vendor at his own discretion. Interference by any Vendor with the activities of another Vendor will not be tolerated. Any such occurrence should be reported to the Bourse Chairman. The Vendor committing the offence may be asked to leave the Show and may be prohibited from participating in any future West Hernando Coin Club events.
- 7. Bourse space must be vacated by 3:30 PM on Saturday of the Show.
- 8. If security is needed beyond the Show closing, contact security upon entering the Show (at the Vendor's expense).
- 9. Vendors are solely responsible for all sales tax in accordance with Florida State law.
- 10. The undersigned states and agrees that he/she is an authorized agent for the Vendor listed below and agrees to full compliance with the contract.
- 11. No signs over 18" high unless approved by the Bourse Chairman.
- 12. Dealers vacating their spaces prior to 2:00 PM will risk loss of table and/or preferred location at future shows.
