### Dive Judges:

- Training required
  - Padonia Park Club – June 8<sup>th</sup> @ 9-12 pm
  - St. Andrews Swim & Tennis Club – June 11<sup>th</sup> 6-8 pm
- (3) judges per home meet required
- (2) judges per away meet, with one of the away judges acting as the referee

### Dive Meet Referee:

- Training required (see: Dive Judges training above for times and locations)
- Required per away meet
- (2) years of judging experience preferred

### Table Volunteer:

- (2 per half) required per meet, home and away

### Ribbon Volunteer:

- (1 per half) required per home meet only

### Announcer Volunteer:

- (1 per half) required per home meet only
