Dennis Wade updated that improvements continue the shotgun range. The center trap house roof has been re-designed to slide off of the trap house to allow easy access for service and reloading. The treasurer released approx. \$500.00 for purchasing metal to replace roofing on all trap houses. Plans to build new frames and install roofs are in progress. Trap houses 2 & 4 will be realigned for better use and safety.

Work to be completed on the shotgun range and patterning board. Also, maintenance and repairs will begin on the pistol range target rack, and the rifle range target frames.

Reviewed that PUF is needed to operate the ranges and for members to maintain their park memberships. PUF was due January 01, 2024. 17 park members have not paid their PUF for 2024. The PUF is still 75.00. Members who have not paid their PUF by Feb 29 will be dropped from the March Park Roster and subject to an additional \$75 reinstatement fee.

Dennis Wade and Ron Byberg have already met or exceeded the required 12 service hours for 2024. Maranatha Team will begin trap practice in March. Road leveling and range maintenance was initiated at the park. Rifle and pistol range was disked to keep down weeds.

Treasury Report was given by K. Wyrick.

Kevin provided financial update. Current combined balance is \$13,327.00. No significant unplanned expenses were incurred. The tax bill from George Lee for the property was paid prior to this meeting. There was a donation this month of \$175.00 and some PUF collected for income of approx. \$950.00. Steps taken to minimize utility expense is successful as this month's utility bill is \$69.00.

Fishing Report was given by Roger Burrows

Roger was only able to trap 4 raccoons this past season.

Around full moon fishing for Shad and the Herring run will be good in the St Stephens area. Crappy should be moving to more shallow waters.

Brim will be active in Lynches River and recommended red worms as best bait.
