Meeting

CRSO report - Steve Cox

Currently 101 members in the park and one pending candidate.

Treasurer report shows favorable balance at this time. Club has approximately \$10,657.00 balance in checking/savings. Does not include Hunt Club balance of approximately 4,060.00. Overall expenditures are below 2023 levels. Expenses were normal this past month. Insurance premium paid to National was higher than expected

John mentioned to be alert to potential chronic wasting disease in deer population. None in our area yet but seems to be moving closer. SCDNR is considering changes in baiting deer as it appears this may be encouraging the spread in the affected areas. No local changes expected in the near future.
