Annual Report

Shree Ravalnath has successfully completed 28th years Journey with the grace & Blessing of Ajara Village deity Shree Ravalnath & Gadhinglaj town deity Shree Kalbhairi and unwavering faith and wholehearted support of all the members, depositors, borrowers, customers & well-wishers.

On the occasion of the 70th All India Cooperation Week, 'Sahkar Dindi' was organized for the first time in Gadhinglaj Taluka. Also, a 'cooperative conference' was organized for the office bearers of various cooperative societies in Gadhinglaj taluka. In this conference, guidance was given on the topic of 'Changing Currents in Cooperation'.

Along with banking business, the Society has always implemented various social activities through social commitment. The Society has provided financial assistance for the embellish of the bus stand at Gadhinglaj. Since last few years Tree plantation is done by the Society for environment conservation. An 'Educational Loan Scheme' has been launched for the children of landless and small landholding members to enable the poor students of rural areas of Jurisdiction of Society to pursue higher education. On the occasion of the 27^{th} anniversary of the Society, 'Balutedar Sanman Thev Yojana' was launched for the financial upliftment of Balutedars who are economically weaker in the Society.
