# **Vice President:**

- Question: Roxanna asked if dues notices could be sent by email. Yes.
- Question: Don Auger asked for his dues notice be sent by email as well.
- Pres Mary Ann informed Landowners to send all corresponding emails to ALL board members in the future.

#### **Architecture Committee:**

- Performed follow-ups on existing approvals and unfinished building time frames.
- Thanked John Gurley, Tom Abbott and Joe Martinez for their experience in the building trades for their expertise.
- Thanked Dianna Ramm and Craig Johnson for their efforts in the office filing misc. paperwork.

### **Roads and Grounds:**

- Continue burn pile maintenance 2-3 times weekly.
- Continue dragging back roads throughout community and repairing bar ditches.
- North and South Lake roads are being widen and bladed.
- Continue repairs on roads due to rain damaged runoff.
- Cut and removed a dead tree across road with the assistance of the Fire Department.
- Surveyed culverts for future repairs reminded Landowners that they were responsible for their own culverts.
- Cibola County road upgrades halted due to equipment repairs.
- Kobota tractor repairs were performed in house.
- Acknowledged Don Parry, Tom Abbott, Jack Mansperger and Cibola road crew for all their continued support.

# **Fire Department:**

Captain Julie Farrell gave a presentation on our "Ready, Set, Go" emergency evacuation program. This will be posted on the new web site going forward.

Captain Farrell mentioned the Emergency Evacuation Safety Zone staging locations which can also be found on the web site. These zones should be only used if the roads going out are congested. It was mentioned that livestock trailers should be staged at these locations to remove Landowner livestock. Captain Farrell mentioned that the volunteer fire fighters would be receiving updated clothing gear to battle wildland fires. Captain Farrell suggested that all Landowners sign up for the "Code Red" and "Everbridge" emergency notification alerts. Turning off propane tanks is the Landowner's choice.

Captain Farrell briefed the Landowners on the new emergency evacuation siren installed and that the horns will be tested monthly on the 1<sup>st</sup> at high noon.

Commons director Don Parry mentioned the power line tree trimming on Continental Divide power line right of way. Continental Divide needs access to their right of way on Landowners property.

#### **Old Business:**

Greg Brooks gave a briefing on where we are with the trail today. This trail is a private trail system for Landowners use only. Mr. Brooks asked for donations for tools and manpower. Question: Gaya asked about insurance notice printed on signs. Yes.

Ron Schali briefed on the fire mitigation efforts being performed in the common areas. Ron has asked for funding to clear additional 10 acres of land for next year.

#### **New Business:**

- Committees are being finalized.
- Volunteer group falls under the TRLA insurance umbrella for future events.
- Airbnb's are not allowed until the CC&R's are reviewed and if proposed we would need a 51% Landowner vote to adopt or reject.
