ROADS REPORT

- Repairs on Black Bear at three locations have been completed. This work included culverts installed and re-graveled at those locations.
- Prep work will begin on Timberlake Road between the cattle guard and the "Y" at Lakeshore Dr., culverts have been installed, then after the Fourth of July, a heavy layer of 1" base course will be installed.
- An inspection of several roads will be made for possible work.
- The section of Timberlake Road from north of Cottonwood to the Box S entrance will "possibly" receive work by McKinley County depending on available money.



WHAT IT TAKES TO PREPARE FOR THE TRLA ANNUAL MEETING

30 days before the Annual Meeting, 570 envelopes are addressed, stamped and stuffed with information for all landowners.

The week before the Timberlake Volunteers scrub, dust, clean windows, mop floors, clean refrigerators and inventory supplies.

The week of: 1) a major grocery list is made and hamburgers, hot dogs, buns, paper supplies, condiments, etc are purchased; 2) the entire grass perimeter is mowed and groomed; 3) barbecues are readied, propane tanks filled and picnic tables, tables and chairs are removed from storage, arranged and cleaned.
