Architectural/Maintenance Report (Steve W.): Everything is quiet. NO approvals this month.

Commons Report (Charley): Steve was talking about getting the bath house ready to open. The furnace in the bath house has been worked on and is up and running. Steve W talked with the Fire Chief (Andy) and as soon as there are a few wet days, he will burn the brush pile. Charlie is working on plans to move the porches out to 10 feet and will also work on the dollar amounts. There are still signs to be put up. There are extra street signs in the shed that Charlie would like to swap out with the current ones and work on the repairing and renewing them. Tom Abbott said that there was a no hunting no shooting sign next to him but the bottom of the post had rotted off. Jim Z. picked it up and brought it to the ranch house for work.

Communications Report (Sharon): Volunteers and Stitchers' now have a drop down on the menu bar of the web site. This site will have information and dates of activities of the Volunteers and of the Stitchers' group. Since Wayne has been ill, the posting of the open Board positions has not been posted.

Old Business:

1. Neighborhood Watch organization update: Nancy W. shared that there was a possible sighting of a person from a previous issue about two weeks ago. If seen call 911 immediately. There is a warrant for his arrest. Call the County Sheriff in which he was spotted. Jim Z. requested a photo, Nancy will send him one.

- 2. "No Hunting" sign plan update: Covered in Commons.
- 3. CC&R update committee discussion: Linda P. that they just need to put a few last things together, e.g.: Wording for those people who want to put animals on their land. They hope to have it all together before the annual meeting. Tom A. asked if the they are going address the part of the covenants, Article IV, Section I, Building Restrictions, was confusing for many. It has been rewritten by lawyers and will be part of the amendments being presented to landowners.
- 4. Code of Ethics for HOA Board members' discussion.: Linda had asked for feedback at the last meeting for any changes/corrections. This is the final draft. Hays said that it is not necessary to put this into the By-Laws (it would be a very tedious and time consuming project. This is a simple Board policy to be included in the Policy and Procedures. The Board would move to adopt this policy and every new member who are either appointed or brought on board, would have to sign it. Linda moved to adopt the Code of Ethics, Sharon seconded, approved. The adopted date will be put on the form. Don was the first to sign his form.
- 5. Sign replacement at the "Y" at cattle guard and the Burn pile.: Don has been waiting for the weather to change a bit. He will get with Charlie to find a sturdy post to put it on and a good location for placement.
- 6. Oso Internet Service update: Steve W shared that we are installed with this very fast service with lots of data. The link is the same, same password. This was a good deal for Timberlake South and the Association. The equipment is on the Snake room south side, on the facia of the eave. Steve will call Hughes Net and cancel service and return the equipment requested.
- 7. Nominating Committee for Annual Meeting: There are three positions open. Steve W will rerun, Kevin F will not, and Don is not running. We are looking for nominees. Sharon will put up notices in the kiosks.
- 8. March Newsletter update. Everything turned into Sharon ad over to Nancy Ramm. Linda will get Volunteer info to Nancy R.
