NEIGHBORHOOD WATCH GROUP UPDATE OCTOBER 17, 2020

- 1. ATI gave me a bid of \$125,000 for four sirens after their engineer reviewed google maps to determine best locations. It appears that purchasing sirens to cover all of Timberlake is not a realistic idea because of the cost.
- 2. Only half of our Zone Coordinators have conducted a test to see how long it takes to notify landowners. The average is about 1 ½ minutes per contact, so within 30 minutes we should be able to contact everyone on the phone tree list either by phone and email. New Coordinators are needed for Zone 9.
- 3. CCT74 Vandalism -the new landowner who works at El Moro has not been able to meet with me yet to look at the vandalism in connection with the cleanup.
- 4. Letters have been sent to Sheriff Silversmith, McKinley County and Sheriff Mace, Cibola County concerning the Labor Day incidents and request for a meeting to talk about these concerns. The Vol Fire Dept.'s concern about more cooperation and ability to give out warning tickets was also included.
- 2. Ranch House porch remodel. Mike Begay is doing cement work, this week doors will be installed, Leesa is painting and staining and the old wall done soon, ceiling needs sprayed. Mike Begay will be finished next week. Charley shared that Don Parry helped Leesa with spraying the outside walls.
- 3. Forest Management Sub-Committee Status.

FOREST RESTORATION & WILDFIRE MITIGATION SUB-COMMITTEE REPORT FOR OCTOBER, 2020

- 1. AIM-application we did not submit another application since we could not get a fiscal agent to work with us. Ramah Navajo charges 70%, which is extreme when compared to the 5% that the Council of Governments previously quoted. We are researching other grant opportunities (ie: FHI might be possible) that should be released in January or February 2021.
- 2. Chipper Day is scheduled for November although Mike Henio still has not given me an exact date. We have four people signed up. If the Ramah Navajo crew would have time leftover, we will have them chip some of the brush under the power lines that has been piled up for several years. 1 ½ to 2 hours will be allotted at each location. Articles will be prepared for the next Timberlake newsletter.
- 4. TRLA Phone Line Improvement Committee: An emailed stated that the replacement work is complete and now they are in the process of taking out all of the old stuff.

- 5. Recording Water Usage updates: Steve water usage is down to 244 gal/day. Julie was called 3 times, Steve was called a couple of times. There was one 100 gal fill and one 250 gal. Steve will do research on a control method at reasonable rate and have information for the February meeting.
- 6. Timberlake Road Signs McKinley County no information
- 7. Cycle Bar Mower discussion. Don said that he wants to survey some more of the type of growth by the lake to help him make a decision that the cycle bar will cut that type of vegetation. He is still looking for a pole saw with a regular saw blade for cutting. There has been zero interest in brush hog.
