Commons Report (Charley/Steve/Don) COMMONS REPORT (for the Board Meeting on 10/21/17 and the upcoming newsletter)

- Painting at Ranch House continues with completion near, fencing is now being done.
   New doors for rear building have been painted and will be hung soon with new pulls and the existing hinges. Fascias and soffit material at this building has also been installed and painted.
- 2) Installation of the "no hunting" signs continues, hopefully completion will be done before winter.
- 3) Electrical work (lights and outlets) at the "Equipment Storage Building" has been completed. Exterior lights are on switches and of the "dark sky" type.
