 - a. Review hierarchy of control (Eliminate, Engineering (no unsafe act), Training, PPE, Written Policies and Procedures, Record keeping, constant analysis)
 - b. PM's Faulty equipment is avoidable, weekly maintenance, tailboard sessions
 - c. Occupational preventative healthcare respiratory hazards, noise exposure, vision impairment, skin exposure, hand, finger or injuries
 - d. EAP Annual training, review the procedure
 - e. Disciplinary and Positive Action Plan
 - f. Discussion and Example:

 - ii. Chris M. (NWE)- Labeling Talking with the field folks, listening for key statements with regards to hazard recognition.

First drill resulted in several new controls to remove hazards. Snappy Joe Valves (many different types out there link will take you to a vendor) on the truck that stops incidental release. Deluge system as ammonia is attracted to water.
