




### What is Benchmarking not?

### It is not:

- Networking
- Just sharing best practices
- Sharing trade secrets
- A competition


### Then what is Benchmarking?

### It is:

- Part of the continuous improvement process
- Benchmarking is a <u>process</u> to measure the quality and performance of your organization's products, services, or processes.
- A multi step process where an organization:
  - 1.Gathers and shares data with a group
  - 2.Determines what "good" looks like (the benchmark)
    - \*Ensure that regulatory requirements are met\*
  - 3.Compare your organizational practices to the benchmark
  - 4. Develop actions plans for continuous improvement

## The Objectives of Benchmarking

- Determine how and where other organizations are achieving high levels of performance
- Comparing industry peer's processes and strategies against you own.
- Use the information gathered from your analyses and comparisons to implement changes that will improve your company's performance, products, and services.
