NEW BUSINESS

GK asked the Financial Secretary if there were any outstanding bill for approval. No new bills at this time. We've paid GK for reimbursement on the coffee and donuts, and have reimbursed brother Victor for the purchase of coats for Coats for Kids program.

For coffee and doughnut Sunday we now have two dates, Jan. 11th and the 8th of Feb. Monsignor has requested that we do not do any dates in Lent. So from Ash Wednesday onward there will be no items in the gathering space until Easter.
