Dance Policy and Procedures

Payment of Fees:

Tuition may be paid by credit card on file on the 1st of the month. All payments received after the 10th of the month are considered late and will receive a **\$15.00 late fee**. A \$20.00 late fee will be administered if the payment is not received by the 1st of the following month. Tuition may also be paid by credit card (Visa or MasterCard) that will be charged the first day of our school month for our school year. The recurring credit card billing contract must be received upon registration to confirm class time(s). No class time(s) will be confirmed without a signed receipt of this credit card billing contract. **NO CHECKS**. All declined credit cards will be charged a \$5.00 Administration Fee (so please keep your credit card billing info updated with the front desk.) Year in Full Payments may also be made to confirm class time(s) with a 10% total discount. Tuition remains the same regardless of absences unless arrangements have been made with the front desk. _____

Missed Lessons and Make-up Lessons (Dance School Only):

You have the opportunity to make-up any missed lessons before the end of the 2025-2026 school year. You may not accumulate more than 4 make-up opportunities at any time. Any classes missed during a period when you already have 4 make-ups in reserve, will not be granted a make-up opportunity. Make ups will not be permitted unless the following steps are taken: 1. Notify the front desk that you are missing class (so we know there is an open spot if someone wants to make-up in your spot) 2. Call to authorize the exact time and day of make-up. Students are not allowed to show up for a class if they are not pre-authorized due to our limited class sizes. 3. Make-ups may not be scheduled more than a week in advance. _____

Costume Fee and Ballet Fees:

No costume fees will be refunded after costume order is placed (no exceptions) - even if a student withdraws from the school. The costume fee is **\$100.00**. Those registered by **Feb 1st** will perform at the end of the year dance recital. Regular class attendance is mandatory in order to participate in the dance recital. **If more than 5 classes are missed between April and June, your student will not be able to perform in the recital. Attendance at the dress rehearsal is mandatory in order to participate in the recital.** Rehearsal classes take place of regular classes the week of the recital and postings of dress rehearsal will be placed up at the studio as well as on the web. Tights, shoes, and accessories (socks or hair bows) are not included in the costume fee. Those Purchase items will be posted and are the parent's responsibility. All one hour ballet classes will also pay an additional fee for costume accessories and props. Cost range for Ballet fee is \$65-\$100. _____

Recital FEE & Tickets: PLEASE READ CAREFULLY!

Each dancer participating in the **June Recital Program** is required to pay the **RECITAL FEE**. *Please see the front page of the registration form for pricing information.* Additional tickets can be purchased for \$25.00 each. Auto pay customers will automatically be charged for the recital fee on June 1st. **Payment is due by June 1st**. _____

Christmas Recital:

Dancer's Turnout will be doing a Christmas Recital in December. We require all performers to purchase a recital leotard, cost \$50. All one hour ballet classes participating in the Ballet opener will also be required to pay an additional fee for costume accessories and props. There will be small costume fees for rec classes (tights, socks, hair bows, leggings, etc) and tickets sold at first come first serve for \$25.00 a ticket.. Info will be posted as a reminder in the lobby and sent in REMIND.. All performers get in Free. _____

Care of Students:

The school is not responsible for providing before or after class care for students. Students are not to be left at the school for excessive time before or after lessons. _____

Parent's Responsibility to be Aware of Dates and Events:

It is the responsibility for parents or the adult to be aware of school activities such as recitals and dates when the school is open and closed. The school will post notices and send notes home with students and update on the web. It is also the responsibility of the parents or adult to be aware of deadlines and inform the school of any address or telephone number change. _____

Holidays:

DTA will observe the following holidays and will be closed: Labor Day, Thanksgiving (1 week), Christmas Break (2 weeks), Easter Break (1 week), 4th of July, and Memorial Day. Tuition for those months will remain the same. Notes and reminders will be posted. _____

Injuries/ Illness:

Parents, legal guardians of minor students waive the right to any legal action for any injury or illness, including Covid-19 sustained on Dancer's Turnout property resulting from normal lesson activity or any other activity conducted by the students before, during or after lesson time. _____

Photo Releases:

The school is hereby granted permission to take photographs of the students to use in brochures, websites, posters, advertisements and other promotional materials the school creates. _____

Withdrawals and Refunds:

There is a two-month minimum for all lessons. One-month notice is required to discontinue any classes. A withdrawal form must be filled out in person and will not be accepted over the phone. Withdrawals must be done at the studio office and not with the teacher. To withdraw from lessons a parent or adult student must: 1. Inform school administration 2. Complete and sign a withdrawal form provided by the school office.

After this point you will have 4 final weeks of lessons to complete (your pre-paid "last month"). **There will be NO refunds**. Any paid lessons beyond the 4 weeks will be credited for class time. Dancer's Turnout reserves the right to terminate lessons to any students without notice. In such a case a refund for unused lessons will be given. Dancer's Turnout reserves the right to refuse service to anyone.
