Conduct Statement

My child agrees to abide by the general rules of conduct prescribed for participation in Big on Basics as posted on the website, www.bigonbasics.com. My child, along with myself understand that among these rules are prohibitions against abusing officials, repeated profanity, flagrant fouls, throwing equipment and any other unsportsmanlike behavior. My child, along with myself further understands that violations of the rules will result in game ejections, suspensions and/or possible perment dismissal from the trainings.

I have read, understood, and agree to follow the Conduct Statement.

Waiver and Release Liability

My child, along with myself understand participating in basketball trainings and events organized or sponsored by Big on Basics (collectively, "Big on Basics Activities") is potentially dangerous or hazardous activity that includes risks, including, but not limited to, the possible of physical harm or injury, permanent disability, death, and damage to property. I hereby expressly and specifically assume all risks, including, but not limited to, the risk of physical harm or injury, permanent disability, death, and damage to property, associated with my participation in Big on Basics Activities, including, but not limited to, falls, contact with other participants, the conditions of gym and event locations, etc. all such risks being know and understood by me.

Having read this Waiver and Release of Liability ("WRL"), knowing, understanding and willing to assume the risks associated with my child's participation in Big on Basics Activities, and in consideration of my child being permitted to participate in Big on Basics Activities, I, for my heirs, executors, administrators, legal representatives, assigns and any other person entitled to act on my child's behalf, as well as myself, hereby waive, release, forever discharge, hold harmless and covenant not to sue Big on Basics, its successors and assigns, its Board of Directors, officers, operators, employees, agents, other participants and any other representative of Big on Basics (collectively, "Released Parties") from any and all claims, demands, suits, judgments, damages, actions and liabilities, of every name and nature whatsoever, whenever occurring, whether known or unknown, contingent or fixed, at law or in equity, which arise or may hereafter arise from my child's participation in Big on Basics Activities. I understand and acknowledge that this WRL discharges the Released Parties from any liability or claim that my child,

along with myself may have against the Released Parties with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my child's participation in Big on Basics Activities, whether or not caused by negligence of the Released Parties. I understand that Big on Basics does not assume any responsibility for or obligation to provide financial assistance or other assistance, in the event of injury or illness to my child caused in any part by his/her participation in Big on Basics Activities.

I hereby release and further discharge the Released Parties from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment or service rendered in connection with my child's participation in Big on Basics Activities.

I expressly agree that this WRL is intended to be as broad and inclusive as permitted by the laws of Georgia, as applicable, and that this WRL shall be governed by and interpreted in accordance with the laws of Georgia, as applicable. I agree that in the event that any clause or provision of this WRL shall be held invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this WRL which shall continue to be enforceable.

Photo and Electronic Media Release Waiver

I hereby grant permission to Big on Basics, its successors, assigns, licensees, and legal representatives, the irrevocable right to use my child's name, picture, portrait or photograph on its world wide web site, in electronic media (e.g., video, social media) or in other printed publications or other forms of promotion without further consideration, and I acknowledge Big on Basics' right to crop or treat the photograph at its discretion, and waive the right to inspect or approve the finished product, including written copy, which may be created in connection therewith. I hereby grant and convey unto Big on Basics all right, title and interest in any and all photographic images and video or audio recordings made by Big on Basics during my child's participation in Big on Basics Activities, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.
