## **Boarding, Daycare, Pet Sitting Conditions and Agreement:**

- 1. Minimum vaccination Requirements for pets are: Dogs: Current Rabies, Bordetella, DHLPP
- 2. All pets will be checked for fleas and ticks upon arrival and if it is established that they carry fleas/ ticks they will be treated with flea spray and or tick bath at the owner's expense. The fee will be \$25.00 for treatment
- 3. Pets must be dog and people friendly. Any dog that bites or is non manageable may be refused. If your pet is to buite or injure one of our employees or another pet while staying at Lake County Pet Sitting. You as the owner will be held liable for any costs incurred by your pets actions.
- 4. Dogs must arrive with collars and leashes.
- 5. Lake County Pet Sitting recommends that the pet owner bring their own food for all their fur guests. If Lake County Pet Sitting has to provide food for the pet. The cost will be \$5.00 per day. This fee will be charged for each pet and will be added to the boarding rate.
- 6. Food should be placed in zip lock bags or small tupperware containers may also be used. Large ones that will not fit in bins should not be used. Large bags 20lbs or larger will be turned away.
- 7. All bedding must be able to fit in a standard washing machine.
- 8. Please list all belongings that you bring with your pet and make sure that all belongings including toys carry your pet's name on them.

- 9. In case the pets become ill or should need the care of a veterinarian the owner of Lake County Petsitting will first call the pets owner at the numbers listed. Following that a mobile vet will be called or the owner can authorize Lake County Pet Sitting to take your pet to a local vet. Charge for the vet will be \$200 plus the vet fees. This includes transportation.
- 10. If any pets are not picked up or arrangements made for the settlement of the bill of the specified departure date, Lake County Pet Sitting may take actions to place the pets in a new home or shelter.
- 11.In the event that an injury or illness is discovered after the pet has left the premises after either boarding or daycare, Lake County Pet Sitting must be contacted within 3 days and prior to any veterinary treatment.
- 12. Pet Owners are responsible for any and all collections, court/ attorney costs, and fees on unpaid bills.
- 13. You as the owner of the pet are responsible for any damage done by your pet to the inside or outside of Lake County petsitting property.

## **Boarding Agreement:**

The described pets will be kept in a clean and sanitary condition with ample food and water at all times. While every precaution will be taken to prevent disease, injury, escape, fire, death, sic=kness, etc animals that are placed in the care of Lake COunty Pet Sitting are placed at the sole risk of the owner of said pets. The owner further agrees to be solely responsible for any and all actions of their pets while he/she/ is boarded or cared for in any matter at Lake County Pet Sitting. Owner agrees that he/she understands that this is a legally binding contract. If not understood please seek the services of an attorney. In signing this contract and leaving his/her pets with Lake County pet sitting the owner certifies to the accuracy of all information given about said pets in this contract.
