- Entries must include copies of appropriate documents including: 4-generation pedigree,
   registration papers (AKC certificate or equivalent), and proof of current rabies vaccination.
- Please bring originals of all appropriate documents to the trial for verification by the Trial Secretary at check-in.
- Don't forget your scorebooks. Only 1 scorebook per dog.
- Payment must accompany your entry form. Refunds will be available up to the filing deadline for the trial, minus a \$10 processing fee, for verified reasons such as illness of the handler or dog.
- DSCSD will provide water and snack items throughout the trial. Please bring your own breakfast and/or lunch for each day of competition.
- Please park in the lot across from the OTL tournament field as indicated on the map and remember to pick up after your dogs.
- The trial and parking area are in a wide open space subject to intense heat during warm weather. Bring shade for your vehicle/dog(s) in case of warm weather. Also, please bring your own chairs for seating during the trial.
- Local lodging is close by; please contact Brian Stafford for details.
