I want to loop you into the first phase of the Connections+ program with Peace Neighborhood Center.

Jennifer and I met with Bonnie and his team today. Jennifer is set to be at Peace on Tuesday and will be working with ensuring their students have technology next week during orientation week.

Heather, we will really need a direct connection with your office to match students from the Peace program with those who still need devices. Jennifer will work on picking up those devices from ITD along with the proper paperwork and deliver devices to the Peace students.

Julie, Jennifer is getting a spreadsheet with all the proper information on each Peace student in their program including parent permission so we can get Peace staff connected to PowerSchool.

We will also need to engage the Schoology training for Peace staff although many stumbled through it this summer. I will contact James directly with Jennifer to get that scheduled.

We are also asking if there is a district access code so that Jennifer can help students get into Schoology if they don't have their Clever badge or a direct line of who she can call?

The key is the connection. We want to ensure that the students from Peace are connected to their schools and that the schools know Jennifer is the conduit between them and Peace. If a student is not online in the morning, Jennifer can work with Peace staff to track down the student. If a para is assigned to a Peace student they need to know Jennifer is their connection as well as the teacher and principal. Of course we are not replacing the Peace staff but providing more of a direct chain of support.

We expect this program to grow so your support as we kick off is vital!



Thanks Liz, the family moving to [REDACTED] has experienced a tremendously difficult year. After so much disruption I think it's best to support any bit of stability and connection they have, especially with Peace being the only in person option between the two. Next year will be tough enough if they have to move schools and are still navigating the circumstances that lead to the displacement. I agree we can assist the family to start building a relationship with CAN, but this also takes time, especially right now without the ability to form in person connections.

Bonnie and his staff have approved of moving the younger children to the MS/HS days. This means we'd only be looking at transportation Mondays and Fridays. Peace is to make a decision by Monday regarding a permanent change to their schedule, but it appears likely that programming will move to Monday afternoons at 12:30-5, Fridays will remain a morning session.

It would probably be advantageous to wait until Monday to finalize any plans. My hope would be that we could begin for both families the following Monday 11/2. Since the students would be in transit during the lunch period on Mondays and possibly missing a few minutes of class on either side, we are awaiting input from schools as well but I don't anticipate a concern.

I don't suppose they'd be allowed to eat on the bus..would they?! Thanks again,

We are not bound by the Peace hours either. We have more flexibility. We could keep them all day one of those days, like Monday, or an extended day. In mid-November Peace will change the Monday schedule to give some much-needed support to the high school students after school. I am not 100% sure they want all these 8 kids for the whole day on Monday but at least they would come until 4pm. This change is still under advisement and would not be implemented for a few weeks, however.

If all 8 could come on Mondays and Fridays (with times TBD), this would be economical in that we could reach 8 children who really need more support while their families get back on their feet. This is a long term commitment, however, on the part of AAPS. 8 children do not fit in one car; only a van or bus. Plus, they would need to make sure they were waiting each morning for the bus to come. On Fridays it would be 7:15am and on Mondays, it would be 12:15pm. I see what Peace goes through each morning when kids are not outside waiting for the bus. It has the potential to be a challenge with 8 children in two locations.

If you do get this approved, I think more details might want to come from Bonnie.

Thanks Liz, the family moving to [REDACTED] has experienced a tremendously difficult year. After so much disruption I think it's best to support any bit of stability and connection they have, especially with Peace being the only in person option between the two. Next year will be tough enough if they have to move schools and are still navigating the circumstances that lead to the displacement. I agree we can assist the family to start building a relationship with CAN, but this also takes time, especially right now without the ability to form in person connections.

Bonnie and his staff have approved of moving the younger children to the MS/HS days. This means we'd only be looking at transportation Mondays and Fridays. Peace is to make a decision by Monday regarding a permanent change to their schedule, but it appears likely that programming will move to Monday afternoons at 12:30-5, Fridays will remain a morning session.

It would probably be advantageous to wait until Monday to finalize any plans. My hope would be that we could begin for both families the following Monday 11/2. Since the students would be in transit during the lunch period on Mondays and possibly missing a few minutes of class on either side, we are awaiting input from schools as well but I don't anticipate a concern.

Jennifer and I met with Bonnie and his team today. Jennifer is set to be at Peace on Tuesday and will be working with ensuring their students have technology next week during orientation week.

Heather, we will really need a direct connection with your office to match students from the Peace program with those who still need devices. Jennifer will work on picking up those devices from ITD along with the proper paperwork and deliver devices to the Peace students.

Julie, Jennifer is getting a spreadsheet with all the proper information on each Peace student in their program including parent permission so we can get Peace staff connected to PowerSchool.

We will also need to engage the Schoology training for Peace staff although many stumbled through it this summer. I will contact James directly with Jennifer to get that scheduled.

We are also asking if there is a district access code so that Jennifer can help students get into Schoology if they don't have their Clever badge or a direct line of who she can call?

The key is the connection. We want to ensure that the students from Peace are connected to their schools and that the schools know Jennifer is the conduit between them and Peace. If a student is not online in the morning, Jennifer can work with Peace staff to track down the student. If a para is assigned to a Peace student they need to know Jennifer is their connection as well as the teacher and principal. Of course we are not replacing the Peace staff but providing more of a direct chain of support.

## **Ann Arbor Public Schools Connections+** **Fall Update 9/3/2020**

The Ann Arbor Public Schools, as part of our current Strategic Partnerships program, is working to create levels of support in collaboration with a selected network of partners via local community centers and organizations through the **Connections+** program.

**Connections+** supports students in their virtual classroom learning through either the A2 Student Link or A2 Classroom Connection programs in collaboration with our Strategic Partners. A majority the **Connections+** program will remain virtual while students are in virtual learning. **Connections+** support is not instructional support but rather the AAPS staff member provides a link to the classroom ensuring students are connected and actively participating in virtual learning. As AAPS moves students back into the classroom on a blended schedule additional in person **Connections+** supports will be activated in our schools and at additional Strategic Partner organizations.

AAPS **Connections+** will concentrate supports for students who are not consistently logging into their virtual classrooms and/or have not been progressing in their learning. These supports will be in place at each school. AAPS staff will be assigned to students for the purpose of working directly with teachers on issues of connectivity in the home, ability to access technology, and mental health and wellness. **Connections+** staff, who are a wide range of AAPS employees including Paraprofessionals, Community Assistants, Teacher Assistants and other staff, will also be in contact with the parent/guardian as well as staff at the community centers, providing the vital connection between the student and the school.

Please note that **Connections+** is not direct instruction or service provision in a school building. Rather it is the opportunity for students to be supervised virtually while accessing their online learning classrooms. Where **Connections+** allows for a student's IEP to be implemented, no IEP Amendment and GFELCP will be required. For those students where **Connections+** is not sufficient to provide a FAPE, an IEP Amendment and GFELCP will be developed.

### **Phase I Connections+** **Fall 2020 - All Students Participating in Online Learning**

#### **Strategic Partner Community Centers**

AAPS will make every attempt to assign an AAPS staff member (not teacher) to the designated community center based on a partner agreement while AAPS is in virtual learning. Students associated with partners and community centers will engage in their virtual classrooms at one of the selected community centers. This assistance is designed to establish critical check-ins with students and ensure they are actively contributing and engaged in the virtual classroom during the community center supervised sessions. While AAPS teachers are engaged with their classrooms virtually additional AAPS staff will provide technology support and work with the community center staff member on any issues that arise. The AAPS staff member will actively build relationships with the students, assist in managing their learning day and be a resource for technology issues that require additional ITD support.

During this phase the community center must follow AAPS health and safety protocols and restrict each student group to less than 10 students per the Governor's Emergency Order.

The AAPS staff member will not provide instruction.

### **AAPS Connections+ School Support**

For AAPS students not directly served by a Strategic Partner community center, AAPS staff will be assigned a caseload of students who are not showing progress in their classes to build relationships and support the student and their family to ensure the student is connected and actively participating in the virtual learning platforms. This support will be virtual unless a decision is made by the school administration to conduct a home visit.

The AAPS staff member will not provide instruction.

## **Phase 2 Connections+ Blended Classroom Supports**

When it is determined to be safe to return to the classrooms on a blended schedule, **Connections+** staff will continue to provide additional support to students on their virtual learning days at the community centers as well as the potential to develop small support groups in the schools. As in Phase 1, support will be focused on helping students access and participate in their virtual learning sessions. Direct instruction continues to be provided by the classroom teacher as defined in each phase. Health and safety protocols as agreed upon for Phase 1 must continue.

**Connections+** is intended to support local non-profit organizations who have an established partnership with the Ann Arbor Public Schools as well as use AAPS staff for critical relationship building and support for students who are not served by the community centers. During Phase 2 of the district's classroom implementation plan, additional community organizations can be considered for **Connections+** support.

### **Connections+ Information to the AAPS Community - Guidelines and Tips**

AAPS knows that other learning groups are being formed throughout the community to support parents and students during this challenging time of the COVID pandemic. To help parents and other organizations who have formed these student learning groups we have compiled suggested guidelines, tips and resources to help sustain a successful virtual classroom learning environment.

As we approach the end of July next week, it's natural to turn our attention to back-to-school, and yet we all understand that this is a most stressful time in considering the upcoming 2020-21 school year in the context of the current COVID pandemic.

Thank you for your amazing work, AAPS team, throughout the spring and during this summer season. Many thanks to those who are working in our summer learning programs and as we dig into preparing for next year.

We will be sharing much more relevant information with you over the coming days, as we continue to monitor daily COVID infection rates and work together in planning and organizing our work in service to children for the 2020-21 school year. I am confident that, together, we will rise to this challenge, and I appreciate each of you.

We discussed the planning in progress for the upcoming school year 2020-21 at the Board of Education Study Session last evening, exploring the following issues:

You can follow the links above for more in-depth information on these topics, or if you are interested in watching videos from the meeting, they are available [here](#). Yet, I wanted to provide in this email general highlights of what staff and families can expect when the school year kicks off.

### **Student Safety First**

Student safety remains our top priority, even before teaching and learning. We are hard-wired for student safety: whether it's a regular school activity, such as serving on bus or street-crossing duty, conducting safety drills or, as a Superintendent, remaining watchful overnight to monitor Michigan winter weather to make the safe weather call for student safety. At times, decisions represent a more significant milestone, such as: fighting a court battle to the Michigan Supreme Court to prevent the open carry of weapons in Ann Arbor and Michigan schools or, back in March, making the anguishing decision to close school buildings to protect students and staff, and today, as we evaluate the prospect of a back-to-school season amidst a historic COVID pandemic. As educators and Trustees, we are designed for student safety; student safety is in our very DNA, and this ever-present priority is what drives our considerations, discussion and decision-making today.

### **The Recommendation**

At this time, as the science and current data do not yet support the safe return of all students to in-person instruction in our buildings, the Ann Arbor Public Schools will begin the 2020-21 school year on a virtual learning status.

The week of August 31<sup>st</sup> is designated as a week of preparation and onboarding activities for AAPS students and families with support from our AAPS team. We will share more specific details about this week of orientation during August.

[All students will report to class online to begin the 2020-21 school year, and learning will be in session in the AAPS, starting on Tuesday morning, September 8<sup>th</sup>.](#)

This Fall 2020 virtual learning approach will feature daily, real-time, interactive learning, students directly engaged with quality AAPS teachers, classes, curricula and broad program offerings. Please note: the plans for fall will provide a dramatically different and improved interactive education experience from the spring experience.

When COVID data supports a safe return to in-person instruction, the AAPS will deploy a phased approach, bringing students in by grade levels and monitoring health data during this process, beginning with the youngest and students with the most need first.

During the 2020-21 school year, three program choices are available to parents.

AAPS programs feature quality AAPS teachers and rich AAPS curricula and programs. These programs include engagement with students, teachers and classes in a real-time, synchronous classroom that provides for regular feedback, skill development, grades and accrues academic progress toward the next grade level and credit toward graduation.

These program offerings include:

**A2 Classroom Connect** - a classroom learning opportunity with quality AAPS teachers and staff, curricula and programs that begins virtually, and when it is safe, students will migrate first to a hybrid schedule and then potentially to full, in-person learning. When needed throughout this school year, students may access this classroom virtually.

**A2 Student Link** – a classroom learning opportunity with quality AAPS teachers and staff, curricula and programs where students are a member of a virtual class, and these students intend to remain entirely virtual AAPS students through at least the fall semester.

**A2 Virtual (Grade 6 -12)** – an independent learning option where students complete their work in a self-paced approach, receive teacher feedback and engage with their teacher one time per week in an interactive session.

### **Connections Base Camp Groups**

Continuing throughout the 2020-21 school year, all AAPS students will be situated and meet regularly in base camp groups (also known by several names across AAPS schools as advisory, forum, SkyTime, etc.). These groups build connections, develop relationships and ensure social-emotional supports are in place throughout the year.

### **Connection+ Plus Supports**

During the time of virtual learning and continuing throughout the 2020-21 school year, AAPS students with the most needs will be provided additional connections and support in small group settings to ensure real-time student and family supports are delivered.

Connection+ Supports are tailored for those students for whom accessing virtual learning presents the greatest challenge. This network of support groups will occur virtually and/or in-person at in-neighborhood community locations, using a safe and socially-distanced approach, dependent on COVID infection circumstances.

Food and nutrition distribution will continue throughout this time, as we have done consistently since March 16<sup>th</sup>.

### **Next Steps**

We will be back in touch over the coming days with more information, to provide opportunities for input and feedback on our planning and to connect with parents

to reserve their fall program preference for their students.

We all understand the most important steps we must take each day in this community to stabilize and improve rates of infection so that we can move forward to return our students and staff to in-person learning in our school buildings:

- Wear a Mask
- Watch Our Distance – 6 ft.
- Wash Our Hands

As we approach this ‘back-to-school’ season, we all hear and understand the collective cry during this COVID time to get ‘back’ to normal, yet we recognize that for this 2020-21 school year, we will not return in the familiar way we used to do school. Instead, we are moving forward to a new way of learning and school, to reimagine learning, to innovate our approach to best serve our students, support our staff, return to school and enrich a healthy Ann Arbor community.

It takes a ‘whole village to raise our children’ well, and there is no more meaningful endeavor in a strong community. This COVID pandemic reminds us of how closely we are all connected; our fates are inextricably tied together, even in the very air we breathe.

We know this Ann Arbor Public Schools community will rise to this current challenge, support each other and together, we will see our way to better days ahead.

Folks, I am looping back to this with some further rationale as to why CAN, Peace and Avalon in the future, would like Schoology access.

It is helpful for them to have this access for the students they serve to help monitor their assignments, download assignments, print and support students in a more comprehensive way.

These community centers also provide a lot of support during asynchronous times and it is logistically much more challenging to get each student's Schoology accounts individually, which was also a big reason that they had a consolidated Powerschool account so that staff could login and review academic and attendance information for all of our students instead of logging in and out for each one.

When working with a few hundred kids a day, it really becomes problematic for them, they report and I can understand.

A parent login might be sufficient but if they can have it set up by toggling between kids without having to sign in and out for every kid would be tremendously helpful. Frankly, they report that any access at this point would be helpful as it has severely limited their ability to help some of the kids on a consistent basis.

It is helpful for them to have this access for the students they serve to help monitor their assignments, download assignments, print and support students in a more comprehensive way.

These community centers also provide a lot of support during asynchronous times and it is logistically much more challenging to get each student's Schoology accounts individually, which was also a big reason that they had a consolidated Powerschool account so that staff could login and review academic and attendance information for all of our students instead of logging in and out for each one.

When working with a few hundred kids a day, it really becomes problematic for them, they report and I can understand.

A parent login might be sufficient but if they can have it set up by toggling between kids without having to sign in and out for every kid would be tremendously helpful. Frankly, they report that any access at this point would be helpful as it has severely limited their ability to help some of the kids on a consistent basis.


