KINSMEN CLUB OF OAKBANK-SPRINGFIELD 50/50 OF THE MONTH RULES & REGULATIONS

- **1. Rules:** These are the official rules and are available upon request and posted on both the Kinsmen Club of Oakbank-Springfield website at <u>https://springfieldkinsmen.ca/online-50%2F50</u> or the purchase portal page at <u>https://www.fundingchange.ca/kcos</u>.
- 2. Eligibility: The Raffle is open to all Manitoba residents or persons who located in the Province of Manitoba when purchasing tickets online. Ticket purchasers must be 18 years of age or older. The following individuals are not eligible to participate in the 50/50 raffle: active members of the Kinsmen Club of Oakbank-Springfield.
- **3. Minor Children:** Adult ticket purchasers are not to give their tickets to a person under the age of eighteen (18) years as required by the Public Guardian and Trustee Act.
- **4.** No Refunds: All tickets sales are final. There will be no refunds issued to anyone for any reason. All tickets purchased and entered into the draw cannot be refunded, including if ticket purchasers made an error in selecting the number of tickets they desire to purchase.
- 5. The Draw: The winning ticket will be selected via Random Number Generator (RNG).
- 6. Winner Notification: The winning ticket number will be posted following the draw no later than 48 hours after the completion of the draw on <u>https://sprinafieldkinsmen.ca/online-50%2F50</u> and <u>https://www.fundingchange.ca/kcos</u>. The prize cheque will be sent to the winner with the customer details provided at time of purchase after the prize has been claimed. In the case of a discrepancy between the posted number and the actual number selected through Random Number Generation, the actual number selected through Random Number Generation will be considered the valid winning number.

The holder of the winning ticket will have until 7:00PM CT, fourteen (14) calendar days from the time of the draw to present the winning ticket to the 50/50 Licensee.

Each prize claimant must provide the Kinsmen Club of Oakbank-Springfield (KCOS) with all information required by provincial gaming regulations to claim a prize.
