Tuition for the first month and materials fees are due by July 31<sup>st</sup>. The first day of school is August 21<sup>st</sup>, 2019.

Tuition is paid on a monthly basis and is due the 15<sup>th</sup> day of each month. A late fee of \$20 will be due if the tuition is not paid by the 20<sup>th</sup> of the month. Please feel free to pay tuition early to help avoid late fees.

Refunds will not be given for student absences. Even when your child is ill, we still are reserving a spot for him/her. Therefore, we will not refund tuition for any illnesses/vacations.

Please notify the school as soon as possible if you intend on withdrawing your child from Elm Park Preschool.
