Thank you for your interest in Elm Park Preschool Academy (EPPA)! The Fall Session for the 2025-2026 school year will span 10 months, from August 13, 2025-June 4, 2026. To secure your child's spot, please complete and return the attached Admission Agreement at your earliest convenience. Once we receive the agreement, you will receive an invoice via Brightwheel for a \$100 Registration Fee and the Material Fee. Payments for both serve as a deposit and will secure your child's spot for the fall term. Please note that both fees are non-refundable, even if you choose not to attend. If your child attended our summer program and you have paid a summer registration fee, your Fall 2025 Registration Fee will be reduced to \$50.

When making a payment with Brightwheel, please note that there is no additional fee if you pay by linking your checking account. However, if you choose to pay with a credit card, please be aware that additional fees will apply. If you prefer to pay by check, please make it payable to <u>Elm Park Preschool Academy</u>.

The first tuition payment is due by August 4, 2025, with subsequent payments due every other week. Invoices will be sent one week in advance to allow 7 days for payment. A late fee of \$25 will be applied if payment is not received by due date. If there is an outstanding tuition balance, it MUST be paid in full before your child can continue attending.

The school will be closed for a total of 4 weeks during the school year: 1 week for Thanksgiving, 2 weeks for Winter Break and 1 week for Spring Break. Please note that parents are still responsible for 50% of tuition during these closure periods. *Please refer to our "Tuition Schedule" and "Holidays/Closure Schedule" for your reference.

Please be advised that refunds will not be provided for student absences, as we continue to incur operating costs and reserve your child's spot, regardless of attendance. If you plan to withdraw your child from EPPA, please notify the school at least 30 days in advance. Refunds will not be issued for last-minute withdrawals.

The first day of Fall Session will begin on Wednesday, August 13, 2025.
