Tuition for the first month is due by July 31st. The first day of school is August 18th.

Thereafter, tuition is paid on a monthly basis and due the 15<sup>th</sup> of every month. A late fee of \$20 will be due if the tuition is not paid by the 20<sup>th</sup> of the month. Please feel free to pay tuition early to help avoid late fees. Tuition is paid by dividing the number of attendance days by 10 monthly period.

We follow all PUSD major holidays and closures. Please see the attached calendar for holidays and closures. For our full calendar, please visit PUSD website until it is posted on our website.

Refunds will not be given for student absences. We continue to have operating costs and save your child's position even when he/she is unable to attend. Therefore, tuition will not be refunded for any illnesses/vacations.

Please notify the school as soon as possible if you intend on withdrawing your child from EPPA 30 days in advanced.

- 9. I agree to the following coronavirus restrictions.
  - A. Children will be screened at the door and children with a fever above 100 degrees F will not be admitted.
  - B. Parents will need to bring their own pens for sign-in/sign-out.
  - C. Children found to develop a fever during the day or feel sick will be quarantined, in this situation, I will pick up my child as soon as possible.
  - D. My child will use hand sanitizer during the day (in addition to washing hands).
  - E. I will set my child up for success by dressing them in potty friendly clothing and easy-open lunch items. (Each time a teacher needs to help a child with toileting or opening food, they will need to wash hands before and after each "help", please keep that in mind).
  - F. I understand that we are in a pandemic and I do not hold Elm Park Preschool responsible for any illnesses that my child may contract at Elm Park Preschool.
  - G. I will keep my child home if they have a fever, cough, difficulty breathing, or other signs of illness within the last 24 hours. Please let the center know if anyone in your house has experienced these symptoms or if anyone in your family has been exposed to any one with suspected or confirmed COVID19 cases.

## FYI- The following coronavirus safety precautions will be in place at Elm Park:

- 1. Children will be kept in the same group with no interaction between groups for the day. Lunch bunch is considered a separate and independent group. If outside equipment is shared, it will be sanitized between groups.
- 2. Parents will sign in daily with their own pens, please drop off quickly and email teachers with questions or concerns. Only students will be allowed to enter the buildings, at drop off, families are asked to maintain a 6-foot distance from other Elm Park families.
- 3. Groups will be brought outside as much as possible to learn & play, children from the same household will be kept in the same groups as much as possible.

- 4. Social distancing- we always teach the children to stay in their own "bubbles" and we will continue to enforce this. If you are worried about exposure, consider having your child wearing a hat with a shield, these can be found on Amazon.
- 5. All staff and students will have their temperatures taken daily to ensure that temps are below 100 degrees F.
- 6. Children will be prompted to wash their hands when appropriate throughout the day (as usual). Children will be encouraged to cover sneezes and coughs (as usual).
- 7. Toys, bathroom fixtures, door handles, etc. will be sanitized continuously.
- 8. Quiet time rest mats will be spaced 6 feet apart, children will be spaced out while eating, sitting every other seat.
- 9. Any confirmed or suspected cases of coronavirus or major illness will be reported to all families immediately.
