Thank you for your interest in Elm Park Preschool Academy (EPPA)! We are excited to offer a 7.5-week program from June 15 to August 5, 2026. To secure your child's spot, please complete and return the attached Admission Agreement at your earliest convenience. Once we receive the agreement, you will receive an invoice via Brightwheel for a \$50 Registration Fee and Material Fee. Please note that both fees are non-refundable, even if you decide not to attend. If your child is continuing with our fall program and you have paid a Summer Registration Fee, your Fall 2025 Registration Fee will be reduced to \$50.

When making a payment with Brightwheel, please note that there is no additional fee if you pay by linking your checking account. However, if you choose to pay with a credit card, please be aware that additional fees will apply. If you prefer to pay by check, please make it payable to Elm Park Preschool Academy.

The first tuition payment is due by June 8, 2026, with subsequent payments due every other week. Invoices will be sent one week in advance to allow 7 days for payment. A late fee of \$25 will be applied if payment is not received by due date. If there is an outstanding tuition balance, it MUST be paid in full before your child can continue attending.

Please note that families must adhere to the specific days they are enrolled for, and switching or swapping enrolled days is not permitted. Families may, however, add an additional day if needed, subject to availability. Additionally, refunds will not be provided for student absences, as operating costs continue and your child's space is reserved regardless of attendance. If you plan to withdraw your child from EPPA, we require at least 15 days advance notice. Refunds will not be issued for last-minute withdrawals.
