

WATER AND SEWER RATES BYLAW
BYLAW 2025-02

A BYLAW OF THE VILLAGE OF WALDECK TO FIX THE RATES TO BE CHARGED FOR THE
USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY
OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

The Council of the Village of Waldeck enacts as follows:

1. This bylaw shall be cited as "The Water and Sewer Rates Bylaw".
2. In this bylaw, including this section:
 - a) "Municipality" means the Village of Waldeck;
 - b) "Clerk" means the Clerk/Administrator of the municipality.
3. The charges to be paid by the water consumer whose water services have been turned on in accordance with the Water and Sewer Management Bylaw shall be those as set forth in Schedule "A" attached hereto and forming a part of this bylaw, whether or not any water is consumed. A water deposit of \$150.00 will be required for the hook-up fee. Water deposit will be applied to final billing.
4. Persons who own or occupy premises that drain into or that are required to be drained into the sewer system in accordance with the Water and Sewer Management Bylaw shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached hereto and forming part of this bylaw.
5. Every customer shall pay a lagoon restoration/infrastructure charge as set forth in Schedule "C" attached hereto and forming a part of this bylaw."
6. Accounts for water and sewer service shall cover a period of three calendar months, and shall be rendered on or before the fifteenth day of the month next following that period.
7. Accounts may be billed on a basis of an estimate of gallons, when an actual reading is not available.
8. Accounts shall be paid when rendered. Service may be discontinued if unpaid sixty (60) days after the date of initial billing. Service may be disconnected unless arrangements are made by the consumer at the office of the municipality. Arrangements can be made for amounts owed that are \$400 and less. No payment arrangements will be made for amounts owed over \$400. A reconnection fee of \$50.00 must be paid along with all amounts outstanding as provided for in Sections 3 and 4.

9. It is the responsibility of the consumer to notify the Clerk when water and/or sewer services are no longer required. The consumer will be responsible for all charges up to the date such notice is received.
10. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.
11. Bylaw 2024-04 is hereby repealed.

thereof	Over 9,000 gallons	\$4.14 per 1,000 gallons, or portion

Lagoon restoration charges shall be as follows for each "three calendar month billing period":
