Executive Summary

Ripreza Fund seeks \$100,000 to provide 100 individuals with up to 12 therapy sessions each (\$100/session, ~\$1,200 per person). Targeting low-income families, addiction recovery, trauma/PTSD survivors, and victims of child abuse, we will fund vouchers paid directly to licensed therapists (in-person/telehealth). Clients will have a responsibility to pay what they can, or a “co-pay” within each session donation to allow Ripreza to support those who genuinely are seeking the backing to help themselves along with being able to ask for help from others.

Since 2012, we have raised funds through events and supported 100+ people into therapy/recovery placements, impacting 100+ families. This program addresses the 40%+ of Americans who skip needed mental health care due to cost.

About Ripreza Fund

Founded 2012 (Run for Recovery event), Ripreza Fund is a 501(c)(3) public charity helping individuals and families access therapy, recovery support, and education. Our proven 3-step approach:

1. **Plan** – Assess needs and connect to professionals
2. **Engage** – Educate families and reduce stigma
3. **Support** – Guide toward purpose and lasting healing

The Need

Financial barriers prevent millions from therapy, worsening mental health crises, addiction relapse, and family strain—especially in underserved Utah communities.

Program Plan

- **Goal:** Fund 100 people with therapy vouchers in 12 months
- **Target:** Low-income, uninsured, recovery-focused individuals/families
- **Delivery:** Partner with 10+ therapists; direct payment vouchers; case management for continuity
- **Timeline:** Launch Q1 2026; full implementation by year-end

Expected Outcomes & Evaluation

- 100 individuals served; 1,200+ sessions funded
- 80%+ client satisfaction; improved mental health indicators (surveys)
- Long-term: Reduced untreated conditions and stronger family resilience
