WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, the Town Clerk is in receipt of a petition entitled "Petition to Change Liquor Authority Classification from Option 3 to Option 1" ("the Petition" hereinafter"); and

WHEREAS, the Petition seeks to place the following question on the ballot for the upcoming General Election:

Proposition No. 1 of 2025:

Shall a person be allowed to obtain a license to operate a tavern with a limited-service menu (sandwiches, salads, soups, etc.) which permits the tavern operator to sell alcoholic beverages for a customer to drink while the customer is within the tavern. In addition, unopened containers of beer (such as six-packs and kegs) may be sold "to go" for the customer to open and drink at another location (such as, for example, at his home)?

Beverage Control Law; and

RESOLVED, by the Town Board of the Town of Orangeville, that the required notice shall be published in the Official Newspaper in the Town of Orangeville at least five (5) days prior to the General Election in accordance with Section 141(3) of Alcoholic Beverage Control Law.

On February 16, 2025 205 was put in to the ditch and rolled at approximately 7p, by the time the truck was removed and towed back to the building it was 1130pm. Truck has been at Marquarts for a couple of weeks, they think the frame is bent. Right now we are waiting for the insurance company adjusters to come up with their estimate before we go any further

Mr. Ahl: Mr. Christ and Mr. Tozier drive responsible, we need to have the trucks slow down and not go so fast. I called Tenco to see if they can speed up the timeline for the new truck, they are checking but explained to me the schedule is tight. Right now they are thinking August. The electric in the building is getting close to being complete. We purchased the heaters from ID booth for #3,514.27. Martin door services installed three door openers in the cold storage building. \$5, 523.60. We opened bids on the addition. Are we accepting any bids?

The Board discussed the building and the purchase of a new truck (cash) or BAN the addition. Will BAN \$335,000 for new truck – questionl plan for addition. For now, we will put a hold on the addition.

Will check with Darrick and get quotes to see if he can fix the areas that shingles blew off.

Supervisor May explained that Invenergy was delivering something and went down Wyoming Hills pond acres roadway with a semi truck and got stuck and slid on the ice! Called Maggie to call someone to get them out. I waiting for Mr. Allen Young to call me back regarding damages to the area.

Mr. Frank Dickes discussed the dates for the Republican Caucus.

Town Clerk Report: The Towns total revenue for the month of February 2025. We had \$45.00 in Zoning, \$153.00 in Dogs, \$110.00 for registrar, other - \$10.00. To the general fund, \$215.00, Zoning -\$45.00, Dogs were \$50.00, \$10.00 late

fees, and \$110.00 for registrar. We disbursed \$85.00 to Wyoming County, and \$18.00 to Ag and Markets for dogs.
