ANTICLES OF INCORPORATION

OF

GATOR CREEK ESTATES INPROVENENT ASSOCIATION, INC.

We, the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation not for profit under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

I - NAME

The name of this corporation shall be GATOR CREEK ESTATES IMPROVEMENT ASSOCIATION, INC.

II - NATURE OF BUSINESS

The general nature of the corporation shall be that of a civic society not for profit for the purpose of providing for community, recreational, social and protective benefits for its members.

III - POMERS

The association may own and maintain property, real and personal, which is necessary or incidental to the attainment of its corporate purposes; contract for, buy and sell services and property necessary or incidental to the attainment of its corporate purposes; and shall have all of the corporate powers granted corporations not for profit under Sec. 617.021, Florida Statutes, 1971, as amended from time to time, except as may be limited or otherwise provided by these Articles.

IV - MEMBERS

any lot in any unit of GATOR CREEK ESTATES, whether presently or subsequently platted, Sarasota County, Florida, as evidenced by a duly recorded deed or other instrument of conveyance, shall be eligible for membership in the association and shall become a member of the association upon payment of the annual dues prescribed

OR BOOK

by the Doard of Directors. Membership in the association shall terminate automatically and immediately when a member's vested interest in the fee title terminates. In the event any lot is owned by a legal entity other than a natural person, the officer, director or other official so designated by such legal entity shall exercise its membership rights. Change of membership in the Association shall be evidenced in the Association records by delivery to the Secretary of a certified copy of the deed or other instrument of conveyance.

y - young rights

Each entire lot shall be entitled to one vote at association meetings, notwithstanding that the same owner may own more than one lot or that lots may be joined together and occupied by one owner. In the event of joint ownership of a lot, the vote to which that lot is entitled shall be apportioned among the owners as their interest may appear, or may be exercised by one of such joint owners by written agreement of the remainder of such joint ownership.

VI - INCOME DISTRIBUTION

No part of the income of this corporation shall be distributed to its members.

VII - EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

VIII - PRINCIPAL OFFICE

The principal place of business of this corporation shall be 1390 Main Street, Sarasota, Florida, with the privilege of having branch or other offices at other places within or without the State of Florida.

IX - MUMBER OF DIRECTORS

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three persons, as sh-11 be designated by the Bylaws.

The first Bylaws of the association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.
