8. TEACHING MERITS

8.1. Pedagogical Training

I have received teaching training in the UK that provided me with skills necessary to construct syllabi and plan courses, develop the appropriate approach to evaluating students, and informed me to deal with various issues that could arise in and outside the classroom context including but not limited to students with disabilities and disruptive behaviour. I have also completed 25 ECTs of three pedagogy-training courses at the University of Helsinki between 2020 and 2021 on Learning in Higher Education;

8.2. Research to Develop Teaching

8.2.1. Integrating Research Literature into Course Design: My teaching practices are deeply informed by current pedagogical research, particularly in the areas of active learning, student engagement, and inclusive education. For instance, I have drawn on scholarship around constructivist learning theory to design my courses around problem-based learning (PBL) and flipped classroom strategies. Research on the value of peer learning and formative feedback has also influenced my use of peer-assessment, student-led discussions, and collaborative tasks—particularly in postgraduate teaching. I actively review recent scholarship in teaching and learning journals to ensure my course design is aligned with evidence-based best practices.

8.2.2. Developing and Testing New Pedagogical Methods: As part of my pedagogical development, I created the writing-buddies group model for PhD students and tested it for two years with two different groups of PhD students at the University of Helsinki. The method is adapted from postgraduate writing group frameworks and designed to foster peer support, regular feedback, and a sense of shared academic identity. Students work in pairs throughout the course, exchanging drafts, offering mutual reflections, and building collegial networks that extend beyond the classroom. This model emerged during the COVID-19 pandemic as a response to the pedagogical and emotional challenges of remote doctoral education. Drawing on research about peer-led writing groups and academic belonging, I structured these models to enhance motivation, reduce isolation, and support ongoing research progress. Feedback from students has confirmed the effectiveness of these methods. One student noted: "Giving and receiving peer critiques built up my confidence as a young scholarly writer. We had a safe and supportive space where I could openly share my concerns, insecurities, and fears about academic writing." Another shared: "This course became one of the few things that made me feel I was still connected to my program and made progress toward my goals." The model is pedagogically innovative and emotionally supportive, contributing significantly to the continuity of learning during crisis conditions.

8.2.3. Contributions to Pedagogical Knowledge through Scholarship: To share the outcomes of the work on a writing group model for PhD students more broadly, I co-authored a journal article with one of the PhD students who participated in the course. Our article, titled "Writing-Buddies Group: A Novel Method for Doctoral Writing Groups at the Time of Poly-Crises", has been submitted to the Journal of University Pedagogy (Jufo 1). The piece documents both the design of the models and their pedagogical and emotional impact on doctoral students during a time of global uncertainty. This collaborative writing process itself exemplified the peer-led, reflective ethos at the heart of the models and contributes to current scholarship on doctoral education and peer-supported learning. Our research is particularly relevant in light of recent structural changes in doctoral education in

Finland, where reforms have intensified the emphasis on performance, funding acquisition, and rapid completion. These shifts—rooted in the neoliberalisation of higher education—have increased competition, precariousness, and emotional pressure among PhD students. Many now navigate their academic journeys with fewer institutional support structures, often feeling isolated and under pressure to produce outputs at the expense of deeper intellectual engagement. The **writing-buddies** group we developed offer a concrete and adaptable model to mitigate these pressures. By fostering peer networks, mutual feedback, and emotional solidarity, the models create sustainable, student-led learning environments that counteract the individualising and competitive tendencies often associated with neoliberal academic culture. The research demonstrates that structured, collective writing support not only enhances academic performance but also strengthens well-being and academic identity—making the approach highly adaptable across institutions facing similar challenges.

8.3. Teaching Experience

I am a highly experienced educator with a broad and diverse teaching portfolio that spans multiple academic levels and international contexts. I have taught in the UK, Turkey, Greece, Sweden, and Finland, and held two full lectureship positions over four years, where I developed strong expertise in independently designing and delivering undergraduate, master's, and PhD level courses—including those focused on research design and PhD seminars. In total, I have designed and led 21 courses: 12 as the sole and responsible teacher, and 9 as a co-teacher. My teaching spans BA, MA, and PhD programs across disciplines such as human geography, urban studies and planning, international relations, political science, and global development studies.

My experience ranges from delivering advanced graduate seminars in small-group settings (fewer than 10 students) to coordinating large introductory undergraduate courses (over 50 students). Specifically, I have taught 10 undergraduate, 7 master's, and 4 doctoral-level courses. In addition, I have been invited to give guest lectures and public talks at institutions including the Architecture Department, STUE, and Postcape at Tampere University; the Bartlett School of Planning at UCL; the Sociology Department at the University of Helsinki; Urban Studies and Planning Department at the University of Sheffield, and the Urban and Regional Planning Department at Istanbul Technical University.
