Violation of this agreement or Complaints towards Subs may result in non-payments or legal action. Any questions may be directed to Jerry Curtis at 435-512-5955 This agreement must be signed before further work is offered to any subs/leasers.

(Leasor) agrees to run at Bulldogg Logistics LLC rates (or current job rate agreed with Bulldogg Logistics LLC. Rates vary depending on Client and will be discussed before any job commences). This agreement guarantees the Sub contractor payment for the work to be done. (Leasor) understands and agrees that to receive payment, the following documentation must be provided to Bulldogg Logistics LLC.

1. Proof of insurance (certificate of liability insurance) With Bulldogg Logistics LLC as additionally Insured.
2. Proof of Workers Compensation coverage and current W9.
3. Tickets must be sent in daily, and invoices by the beginning of the new week.
4. Paperwork must be filled out in full with job names, job #'s, Phase codes & addresses if available etc.
5. Tickets MUST have a Signed Signature from client at the end of each day/Or communication with dispatch before leaving the job.
6. Bulldogg Logistics LLC Paperwork (Unless other Paperwork is directed) Must be used on all jobs. Other Paperwork or Company Terms WILL not be enforced if accounts require Attorneys, Collections, Etc.
7. ALL TICKETS must be sent to Bulldoggdispatch@gmail.com
8. Tickets must be turned in by 9am the following business day.
9. Any Tickets turned in later than 24 hours after day worked will be charged \$50 Processing Fee for ticket that are still able to be processed.

10. It is YOUR responsibility to make sure you and YOUR FACTORYING company that you work with, have the correct rates and are sending paperwork on time. We are not responsible for you or your Factoring companies' errors.

(Leaser) understands and agrees that the production of the requested documentation is to take place annually. If (Leasor) fails to provide the documentation (Bulldogg Logistics LLC) may not be held liable for payment to (Leasor).

(Leasor) understands and agrees to provide proof of work to Bulldogg Logistics LLC in the form of daily truck tickets and invoices. If (Leasor) fails to provide tickets and/or invoices of work performed for (Bulldogg Logistics LLC) within 45 days of completion of daily work, (Bulldogg Logistics LLC) may not be held liable for payment to (Leasor). IF Paperwork or invoices are REJECTED by the client for ANY reason, and it is the Subcontractor at fault, we are NOT liable to make payments to Subs for any such issues. (Improper Documentation of Paperwork, Kicked Off Job, damages done onsite etc.)

Bulldogg Logistics LLC Pre-Liens 95% OF EVERY Awarded Project.

If account passes 90 days, we then will lien projects that are lien-able, and letters from our paralegal department will be sent. Bulldogg Logistics LLC is Not responsible for non-payments by clients and will not be liable to compensate Subs for jobs not Paid by customers. The work performed will be to the standards outlined in the description of the project provided to the (Leasor), to be considered acceptable.

Definitions. "Clients" and/or "Client" shall mean Persons (defined above) who purchased, contracted or otherwise acquired services and/or products from Contractor.

"Person" or "Persons" means any natural person, firm, partnership, joint venture, corporation, limited liability company, limited liability partnership, business venture, trust, association, consumer organization, state, local or federal government agency, branch, department or other governmental unit, or any other entity.

"Time Period" shall mean the period beginning on the date of the date hereof and ending one

(1) year after the date that (Leasor) no longer performs work for (Bulldogg Logistics LLC); however, if a court of competent Jurisdiction determines that such a one-year period is unenforceable, Time Period shall mean the period beginning on the date of the date hereof and ending six (6) months after the date hereof.

By signing this agreement, both (Leasor) and (Bulldogg Logistics LLC) are agreeing to all terms above.
